FOOT-AND-MOUTH DISEASE DECLARA TION OF INFECTED AREAS ORDER OF 1926 (No. 43).

The Minister of Agriculture and Fisheries. by virtue and in exercise of the powers vested in him under the Diseases of Ânimals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows :-

Extension of certain Infected Area.

1. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 41) shall be read and have effect as if the area described in the Schedule to this Order were substituted for the Infected Area No. 10 described in the Schedule to that Order.

Short Title.

2. This Order may be cited as the FOOT-AND-Mouth DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 43) and shall be read with the Order referred to in Article 1.
