## TRADE BOARDS ACTS, 1909 AND 1918.

## VARIATION OF MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF FEMALE WORKERS IN THE ROPE, TWINE AND NET TRADE.

The Rope, Twine and Net Trade Board (Great Britain) have issued a Notice dated 7th April, 1926, setting out all the minimum rates of wages in operation in the Trade, including the minimum rates AS VARIED for certain classes of female workers which take effect under an Order of the Minister of Labour as from 12th April, 1926.
