ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 9TH APRIL, 1926.)

FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 59).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Contraction of Certain Infected Area.

1. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 57) shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Infected Area described in the Schedule to that Order.

Commencement.

2. This Order shall come into operation on the fifteenth day of April, nineteen hundred and twenty-six.

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 59).

5. An Area comprising:—

In the county of Surrey.

The boroughs of Kingston-upon-Thames, Richmond and Wimbledon.

The petty sessional divisions of Mortlake, Kingston (*except the parishes of Walton-upon-Thames, Cobham and Stoke D'Abernon*), Wimbledon and Sutton, and the parishes of Cheam, Cuddington, Ewell, Chessington, Epsom and Mitcham and so much of the parish of Carshalton as lies to the north of the railway line running from Mitcham Junction to Sutton.

In the county of Middlesex.

The parishes of Twickenham, Teddington, Hampton and Hampton Wick.

In the county of London.

The borough of Wandsworth.

FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 60).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Release of a Certain Area from Restrictions and Revocation of Certain Order.

1.—(1) The Infected Area No. 3 described in the First Schedule to the Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 55) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

(2) The Foot-and-Mouth Disease (Birmingham Pig Market) Order of 1926 is hereby revoked.

(3) This Article shall come into operation on the fifteenth day of April, nineteen hundred and twenty-six.

Release of a Certain Area from Restrictions.

2.—(1) The Infected Area No. 2 described in the First Schedule to the Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 55) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

(2) This Article shall come into operation on the sixteenth day of April, nineteen hundred and twenty-six.
