CARK AND DISTRICT ELECTRICITY.

NOTICE is hereby given that the Cark and District Electricity Company Limited (hereinafter called "the Company") whose address is Electricity Works, Flookborough, Cark-in-Cartmel, Lancs. have applied to the Electricity Commissioners for a Special Order (hereinafter called "the Order") under the Electricity (Supply) Acts 1882 to 1922 for all or some of the following amongst other purposes (that is to say):—

1. To supply electricity in the whole or part of an area comprising so much of the Parishes or Townships of Lower Holker and Lower Allithwaite as lies to the South of an imaginary straight line commencing at the Junction of the two roads twelve yards or thereabouts north of Bigland Scar Cottages on the western boundary of the Parish or Township of Lower Holker and proceeding in an easterly direction to and terminating at the cross roads at High Fell Gate on the eastern boundary of the Parish or Township of Lower Allithwaite and more clearly shown on maps which can be inspected at the office of the Company at Flookborough aforesaid and also at the office of Messrs. Poole & Son, Solicitors, Ulverston.

2. To authorise the Company to supply, distribute and sell electrical energy for all public and private purposes as defined by the Electricity (Supply) Acts 1882 to 1922 within all portions of the aforesaid area and in particular for such purposes to lay down suitable mains within a period of two years after the commencement of the Order in the following roads or streets, that is to say:—

In the rural district of Ulverston:—

Parish or township of Lower Allithwaite:—

Home Lane and Church Street, from Lane End to St. Mary's Church, Flookborough Road from Lane End to Barn Hay Farm and from Yew Tree Farm to the School on Cartmel Road.

Parish or township of Lower Holker:—

Jutland Village, from Mire Side Farm along Winder Road to Feeder Pillar in Jutland Avenue and from thence along Jutland Avenue, Marne Avenue, Arras Avenue and Somme Avenue.

Main Street of Flookborough Village.

Main Street of Cark Village from Power Station to Cark Hall and along Cross Road to The Green.

Cartmel Back Lane from Power Station to Birkby Hall.

From Mire Side to Sewage Pumping Station near Raven Winder.

Ulverston Road from the Bridge over stream in Cark Village through Holker to Holker Hall Home Farm.

3. To incorporate in the Order such of the provisions contained in the Schedule to the Electric Lighting (Clauses) Act 1899, as are applicable, and to apply such provisions to the undertaking authorised by the Order, subject to such variations and exceptions as may be contained therein.

4. To prescribe the maximum price or maximum prices that may be demanded and taken by the Company in respect of the supply of electrical energy within the aforesaid area and to prescribe the minimum prices to be paid by persons supplied with electricity by the Company or connected to their electricity undertaking in the aforesaid area.

5. To authorise the Company to open and break up in the aforesaid area the following streets and parts of streets which are not repairable by the local authority (namely):—

In the rural district of Ulverston:—

(a) Parish or township of Lower Allithwaite:—  
Jack Hill.

(b) Parish or township of Lower Holker:—  
Any side road or street which at present is unnamed and leads to a house or block of houses and over which the public or private persons have rights of passage or user.

6. To confer upon the Company all or some of the powers of the Electricity (Supply) Acts, 1882 to 1922 and the enactments incorporated therewith, and to alter, vary or extinguish all rights and privileges which would, or might interfere with any of the objects of the Order, and to confer all other rights and privileges necessary for carrying such objects into effect.

Every local or other public authority, company or person desirous of bringing before the Electricity Commissioners any objection respecting the application, may do so by registered letter addressed to the Secretary of the Electricity Commission, Savoy Court, Strand, W.C. 2, and despatched on or before the 23rd day of May, 1926, and a copy of such objection must also be forwarded to the undersigned Secretary of the Company or Solicitor.
