IN THE MATTER OF THE BANKRUPTCY ACT, 1914.

Whereas with the concurrence of His Majesty's Treasury, the Board of Trade by a Minute dated the 21st day of April, 1926, appointed Mr. Frederick Murgatroyd as from the 1st day of November, 1925, to be an Official Receiver for the districts of the following County Courts exercising Bankruptcy jurisdiction, viz., the Manchester, Bolton, Ashton-under-Lyne and Stalybridge, Oldham, Rochdale, Stockport and Salford County Courts.

And whereas Mr. John Grant Gibson was previously appointed and still remains an Official Receiver in Bankruptcy for the said districts and there are now two Official Receivers for the districts of the said Bankruptcy County Courts.

Now, therefore, the Board of Trade by virtue of Rule 308 of the Bankruptcy Rules, 1915, hereby direct that where on and after the 28th day of April, 1926, Receiving Orders are made by the said Manchester and Bolton Courts respectively, Mr. John Grant Gibson shall be the Official Receiver for the purpose of such Receiving Orders and the estates thereunder shall be assigned to him, and the Board of Trade hereby further direct that where on and after the 28th day of April, 1926, Receiving Orders are made by the following County Courts, viz., Ashton-under-Lyne and Stalybridge, Oldham, Rochdale, Stockport and Salford, Mr. Frederick Murgatroyd shall be the Official Receiver for the purposes of such Receiving Orders and the estates thereunder shall be assigned to him, and the Board of Trade further direct that for the purposes of Receiving Orders which have been made prior to the said 28th day of April, 1926, the estates shall be assigned and shall be deemed to have been assigned to the said Mr. John Grant Gibson.
