ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.
(DATED 30TH APRIL, 1926.)

Whereas the Minister of Agriculture and Fisheries has found Foot-and-Mouth Disease to exist in an animal on the S.S. "Helenus" now at the Royal Albert Docks, London;

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

1. With a view to prevent the introduction and spread of Foot-and-Mouth Disease, an Inspector of the Ministry of Agriculture and Fisheries acting by direction of the Minister, may by notice served upon the Master of the S.S. "Helenus," prohibit—

(a) the landing therefrom in Great Britain of any portion of the cargo, and

(b) require the cleansing and disinfection of any part of the said vessel or of anything thereon in such manner as the Inspector may direct.

2. On the service by an Inspector of a notice under Article 1 of this Order it shall be unlawful to land anything specified in the notice except with a licence granted by an Inspector of the Ministry and subject to such conditions as regards subsequent detention and disinfection or otherwise as may be specified in the licence.

3. Copies of any notice served under this Order shall be sent to the Commissioners of Customs and Excise and also to the Ministry of Agriculture and Fisheries.

In witness whereof the Official Seal of the Minister of Agriculture and Fisheries is hereunto affixed this thirtieth day of April, nineteen hundred and twenty-six.
