## ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 18th May, 1926.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:-

therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:-

 This Order may be cited as the Salford Registration of Births, &c. (Alteration of Sub-districts) Order, 1926, and shall come into operation on the 1st day of June, 1926.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. In this Order, "Ward" means a Ward of the City of Salford for the election of councillors.

4. The Sub-districts  $\mathbf{of}$ Pendleton, Broughton, Greengate and Regent Road shall cease to exist and the Salford Registration District shall be re-divided into three Sub-districts to be named and constituted as follows:-

North Salford.—To consist of the Kersal, Mandley Park, Charlestown, Albert Park and St. Matthias Wards.

South Salford.—To consist of the Crescent, Regent, Ordsall Park, Docks and Trinity Wards.

West Salford .- To consist of the Civil Parish of Pendlebury and the Claremont, Weaste, Seedley, Langworthy, St. Paul's and St. Thomas' Wards.

5. The Registrars of the existing Broughton, Greengate and Regent Road Subdistricts shall be, respectively, the Registrars of the North Salford, South Salford and West Salford Sub-districts constituted by this Order.
