maps, and extending thence north eastward to and along such fence for a distance of  $3\frac{1}{2}$  chains or thereabouts to the point where such fence crosses the middle of the stream which runs northward from near Uzzicar farmhouse into the stream known as Newlands Beck, and extending thence first north eastward and then in various directions along the middle of the first mentioned stream for a distance of  $11\frac{1}{2}$ chains or thereabouts to the point where such stream turns eastward along the northern side of the fence on the northern side of the road known as Uzzicar Lonnin, and extending thence first southward to and then first eastward and then in various directions along the middle of Uzzicar Lonnin (thereby crossing the boundary which divides the said New Parish of Thornthwaite from the said Parish of Crosthwaite) for a distance of 241 chains or there-abouts to a point opposite to the western end of the fence which divides the close numbered 454 upon the said maps from the close numbered 455 upon the same maps, and extending thence first north eastward to and then first north eastward and then in various directions along the fences which divide the said close numbered 454 and the close numbered 448 upon the said maps from the said close numbered 455 and the closes numbered 447 and 446 upon the same maps for a distance of  $18\frac{1}{2}$ chains or thereabouts to the point where the fence which divides the said close numbered 448 from the said close numbered 446 meets the fence on the western side of Braithwaite Road, and extending thence first eastward to and then southward along the middle of Braithwaite Road for a distance of 31 chains or thereabouts to its junction with the road leading from Swinside to Skelgill Bank, and extending thence first eastward and then in various directions along the middle of the last mentioned road for a distance of 32 chains or thereabouts to a point opposite to the eastern end of the fence which divides the close numbered 437 upon the said maps from the close numbered 433 upon the same maps, and extending first westward to and then first south westward and then in various directions along the fences which divide the said close numbered 437 and the closes numbered 432, 364, 363 and 361 upon the said maps from the said close numbered 433 and the closes numbered 430, 365 and 367 upon the same maps for a distance of 30 chains or thereabouts to the point where the fence which divides the said close numbered 361 from the said close numbered 367 meets the fence on the northern side of the road leading along the western side of Skelgill Bank, and extending thence first south eastward to and then south westward along the middle of the last mentioned road for a distance of 351 chains or thereabouts to the boundary which divides the said Parish of Crosthwaite from the said New Parish of Newlands."

And whereas drafts of the said Scheme or Representation have been transmitted to the Patrons and to the Incumbents of the Cures affected by the arrangements which are contemplated by such Scheme or Representation and such Patrons and Incumbents have respectively signified their assent thereto:

And whereas the said Scheme or Representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme or Representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Carlisle.
