MINISTRY OF HEALTH.

THE DUDDON ESTUARY (SHELL-FISH) REGULATIONS, 1926.

Notice is hereby given under the Rules Publication Act, 1898, that it is proposed by the Minister of Health, after the expiration of at least 40 days from this date to make regulations prohibiting the sale or distribution for human consumption of mussels taken from that part of the Duddon Estuary, including Haverigg Spit and the Small Deeps Channel, which is bounded at the landward end by a line drawn from Hodbarrow Point to Ireleth Church; and at the seaward end (a) on the Lancashire side by the Scarth Channel and (b) on the Cumberland side by a line drawn in a westerly direction from Haverigg Point unless and until they have been subjected either (a) to a process of cleansing which the Minister of Health, after consultation with the Minister of Agriculture and Fisheries, has approved or (b) to a process of sterilization which the Minister of Health has approved.
