IMPERIAL SERVICE MEDAL.

The notice regarding James Fohy in Gazette No. 33040 of the 21st April, 1925, is hereby cancelled, it having been subsequently ascertained that this person died before the date of the award therein notified.

The Secretary of State for the Home Department hereby gives notice, in pursuance of Section 86 (1) of the Factory and Workshop Act, 1901, that on the 21st June, 1926, he made Regulations, under Section 79 of the said Act, to apply to all premises on which machinery worked by steam, water or other mechanical power is temporarily used for the purpose of the construction of a building, or for the purpose of any addition to the structure of an existing building. The Regulations, which may be cited as the Building Regulations, 1926, come into force on the 1st October, 1926.

APPOINTMENT OF STANDING FOR  
FIFTEEN HACKNEY CARRIAGES.

*By virtue of the Act 13 and 14 Victoria, Chapter 7, intituled "An Act for Consolidating the Office of the Registrar of Metropolitan Public Carriages with the Office of Commissioners of Police of the Metropolis, and making other Provisions in regard to the Consolidated Offices."*

I, WILLIAM THOMAS FRANCIS HORWOOD, Commissioner of Police of the Metropolis, do hereby APPOINT a Standing for fifteen Hackney Carriages at Upper Richmond Road and Oxford Road, Putney, in three portions, and do make the following Regulations with regard to the Boundaries for the same, viz. :—

*First Portion.*—Five Carriages at Upper Richmond Road, in centre of roadway, East of the Refuge, commencing at a point in line with the centre of No. 200, Upper Richmond Road, extending Eastward as far as necessary for five carriages.

Front of vehicles toward the West.

*Second Portion.*—One carriage at Oxford Road, on West side of roadway, commencing two yards North of the crossing at Upper Richmond Road.

Front of vehicle toward the South.

*Third Portion.*—Nine carriages at Oxford Road, on West side of roadway, commencing one foot North of rear gateway of No. 140, Upper Richmond Road, extending Northward, by kerb, as far as necessary for nine carriages.

Front of vehicles toward the South.

The first portion of the standing to be fed exclusively by the carriage from the second portion, and the second portion from the third portion.

Provided that no Hackney Carriage shall be suffered to stand across any Street or Thoroughfare, or opposite the end of any Street or Carriageway, or upon any place where Foot Passengers usually cross the Carriageway.
