

Leonard, Bishop of Ely (in testimony whereof he has signed this Scheme and sealed the same with his Episcopal Seal), and with the consents of the persons to whom, together with the said Reginald Ailwyn Fellowes, and the said Leonard, Bishop of Ely, it is hereinafter recommended and proposed that the said Advowson or perpetual right of Patronage should be transferred, that is to say, with the consents of the Venerable Kenneth Davenport Knowles, Clerk in Holy Orders and Archdeacon of Huntingdon, of Francis John Fallowfield Curtis, of Number 41, Park Square, Leeds, Solicitor, of Samuel Francis Staffurth, of Ramsey, Esquire, of Aubrey Radway, of the Abbey Estates Office, Ramsey, Land Agent, of Richard Flowers Serjeant of Westward Ho, Ramsey, Solicitor (in testimony whereof they have signed and sealed this Scheme), we, the said Ecclesiastical Commissioners for England, humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme and without any conveyance or assurance in the law other than such duly gazetted Order the whole Advowson or perpetual right of Patronage of and presentation to the said Benefice of Saint Mary, Ramsey, shall be transferred to the said Reginald Ailwyn Fellowes; Leonard, Bishop of Ely; Kenneth Davenport Knowles; Francis John Fallowfield Curtis; Samuel Francis Staffurth; Aubrey Radway; and Richard Flowers Serjeant, and shall thereupon and thenceforth become and be absolutely vested in and shall and may from time to time be exercised by the said Reginald Ailwyn Fellowes; Leonard, Bishop of Ely; Kenneth Davenport Knowles; Francis John Fallowfield Curtis; Samuel Francis Staffurth; Aubrey Radway; and Richard Flowers Serjeant, their heirs and assigns for ever as Trustees upon the trusts declared by a certain Indenture already prepared and intended to be executed by the said Reginald Ailwyn Fellowes; Leonard, Bishop of Ely; Kenneth Davenport Knowles; Francis John Fallowfield Curtis; Samuel Francis Staffurth; Aubrey Radway; and Richard Flowers Serjeant.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any further or other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament."

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Ely.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 16th and 17th years of Her late Majesty Queen Victoria, Chapter 50, and of the Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, duly prepared, and laid before His Majesty in Council, a Scheme bearing date the 20th day of May, 1926, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 16th and 17th years of Her late Majesty Queen Victoria, Chapter 50, and of the Act of the 23rd and 24th years of Her said late Majesty, Chapter 124, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting an exchange of the Patronage of the Benefice (being a Rectory) of Burmarsh, situate in the County of Kent and in the Diocese of Canterbury, for the Patronage of the Benefice (being a Rectory) of Ivychurch, situate in the said County of Kent and in the said Diocese of Canterbury:

"Whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Burmarsh is vested in Your Majesty, Your Heirs and Successors, in right of the Crown, and such right of Patronage is exercised by the First Lord of Your Majesty's Treasury for the time being acting on behalf of Your Majesty:

"And whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Ivychurch is vested in the Archbishop of Canterbury for the time being:

"And whereas the Right Honourable Stanley Baldwin, now First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty as aforesaid, and the Right Honourable and Most Reverend Randall Thomas, now Archbishop of Canterbury, have respectively signified to us their desire that the Patronage of the said two Benefices of Burmarsh and Ivychurch may be rearranged by way of exchange in the manner which is hereinafter recommended and proposed:

"And whereas we have made due inquiry and calculation as to the circumstances and relative value of the said two Benefices and of the Patronage thereof respectively and we do hereby certify to Your Majesty in Council that the circumstances and present values of the said two Benefices are as set forth in the Schedule hereunto annexed:

"And whereas the yearly value of the said Benefice of Burmarsh in Your Majesty's Books is £20 10s. 10d. and the yearly value of the said Benefice of Ivychurch in the same Books is £44 16s. 8d.;

"Now, therefore, with the consent of the said Stanley Baldwin, acting as such First Lord of Your Majesty's Treasury (in testimony whereof he has signed and sealed this Scheme), and with the consent of the said Randall Thomas, Archbishop of Canterbury (in testimony whereof he has affixed his signature and Archiepiscopal Seal to this Scheme), we, the said Ecclesiastical Commis-
