made shall have been placed upon the same endowments, the said Benefice of Heston will

still be sufficiently endowed:

"And whereas the said Arthur Foley, Bishop of London, has represented to us, and we are of opinion that it is desirable that additional provision should be made for the Cure of Souls within the New Parish of Hounslow aforesaid, by means of that apportionment of the income of the said Benefice of Heston which is hereinafter recommended and proposed:

"And whereas the said Benefice of Heston is now full, the Reverend Francis William Arthur Wilkinson being the Vicar or Incumbent thereof:

"Now, therefore, with the consent of the Right Honourable and Most Reverend Randali Thomas, Archbishop of Canterbury, acting as Archbishop of the Province within which each of the said two Benefices is situate, and with the consent of the said Arthur Foley, Bishop of the said Diocese of London, acting as such Bishop and also as the Patron in right of his See of each of the said two Benefices as aforesaid (in testimony whereof they the said consenting parties have respectively signed this Scheme and sealed the same with their several Episcopal Seals), we, the said Ecclesiastical Commissioners, humbly recommend and propose that without any conveyance or assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and as from the day of the date at which the said Benefice of Heston shall from whatsoever cause be next avoided, or from the date of the cessation of any pension payable out of the income of the said Benefice to the said Francis William Arthur Wilkinson in the event of the said Francis William Arthur Wilkinson resigning the said Benefice under the Incumbents' Resignation Acts, the sum of £3,333 6s. 8d. India £3 per cent. per annum Stock being part of the aforesaid sum of £20,116 2s. 0d. India £3 per cent. per annum Stock shall cease to form part of the endowments of the said Benefice of Heston and shall be held by us, the said Ecclesiastical Commissioners, in trust for and for the benefit of the Vicar or Incumbent of the said Benefice of Hounslow and as part of the endowments of that Benefice.

"Provided always that the whole of the First Fruits and Tenths now payable to the Governors of Queen Anne's Bounty in respect of the said Benefice of Heston shall continue to be payable by the Vicar or Incumbent of that Benefice.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions

of the said Acts, or of either of them, or of any other Act of Parliament."

And whereas the said Scheme has been

approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of London.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 10th day of June, 1926, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the 3rd and 4th years of Her late Majesty Queen Victoria, Chapter 113, and of the Act of the 6th and 7th years of Her said late Majesty, Chapter 37, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for constituting a separate District for spiritual purposes to be taken partly out of the Parish of Horton, partly out of the Parish of Gussage Saint Michael, all in the County of Dorset and in the Diocese of Salisbury:

of Salisbury:
"Whereas we are satisfied that the said Parish of Horton, the said Parish of Wimborne Saint Giles and the said Parish of Gussage Saint Michael are Parishes wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said Parish of Horton, of the said Parish of Wimborne Saint Giles and of the said Parish of Gussage Saint Michael which are hereinafter mentioned and described should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas by a certain Indenture bearing date on or about the 10th day of June, 1926, and made or expressed to be made under the authority of the 'New Parishes Acts, 1843, 1844 and 1856, or some or one of them, between \mathbf{the} \mathbf{Right} **Honoura**ble Anthony, Earl of Shaftesbury, of the first part, the Right Honourable Constance Sibell, Countess of Shaftesbury, wife of the said Anthony, Earl of Shaftesbury, of the second part, and us, the said Ecclesiastical Commissioners, of the third part, the said Anthony. Earl of Shaftesbury, did, for the purpose of providing an endowment for the said proposed separate District, appoint, grant and confirm unto the Minister of such District (so soon as a Minister shall have been licensed) and to his
