### BUTTON MANUFACTURING TRADE BOARD (GREAT BRITAIN).

#### PROPOSAL TO VARY AND FIX MINIMUM RATES FOR CERTAIN CLASSES OF MALE WORKERS.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, 1st August, 1922, and 1st April, 1926, respectively, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain for the Button Manufacturing Trade, as specified in the Appendix to the Trade Boards (Button Manufacturing) Order, 1925, HEREBY GIVE NOTICE that they PROPOSE TO VARY the minimum rates of wages for male workers at present in operation and set out or referred to in the Notices V. (12) dated 3rd January, 1924, and V. (17) dated 30th June, 1926, in their application to the classes of workers specified in the Schedule below, and PROPOSE TO FIX minimum rates for Male Turners and Cutters by Machine who are not responsible for setting their own tools and who are employed in those branches of the trade included by the Trade Boards (Button Manufacturing) Order, 1925, which are not included by the Trade Boards (Button Making) Order, 1919, the proposed variations and the proposed rates being as shewn in the Schedule below.

This Notice of Proposal is issued with the consent of the Minister of Labour.
