Notice is hereby given that the Minister of Transport by virtue and in exercise of the powers given to him by Section 7 of the London Traffic Act, 1924, the London Traffic (Restricted Streets) Regulations, 1925, the London Traffic (Restricted Streets) (No. 2) Regulations, 1925, and the London Traffic (Restricted Streets) (No. 3) Regulations, 1925, after consulting the London and Home Counties Traffic Advisory Committee, has relaxed the restrictions and limitations imposed by Regulation 2 of each of the said Regulations upon the occasion of the Royal Naval and Military Tournament to be held at Olympia daily from Thursday the 8th day of July, 1926, until Saturday the 24th day of July, 1926, so that nothing in the said Regulations shall prevent any person who is maintaining at the date of this Notice a regular service in accordance with Section 6 of the London Traffic Act, 1924, upon the approved

route numbered 295 from using on those days after the hour of 12 noon in any of the streets or parts thereof between East Ham and Richmond declared to be "restricted streets" by the London Traffic (Restricted Streets) Order, 1925, the London Traffic (Restricted Streets) (No. 2) Order, 1925, and the London Traffic (Restricted Streets) (No. 3) Order, 1925, and forming part of that approved route one omnibus, in addition to those now used in the maintenance by him of any service or services on any approved route on that part of approved route No. 295 which lies between East Ham and Richmond provided that nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioners of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give direction to constables for keeping order and for preventing any obstruction of the thoroughfares.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 7TH JULY, 1926.)

FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 86).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Declaration of Further Foot-and-Mouth Disease Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 74) shall be read and have effect as if the Area described in the Schedule hereto were included as Area No. 9 in the First Schedule to that Order.

Short Title.

2. This Order may be cited as the FOOT-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 86) and shall be read with the Orders referred to in Article 1.
