Further Infected Area.

9. An Area comprising :---

In the county of Stafford.

The county boroughs of Smethwick, Walsall, West Bromwich and Wolverhampton.

The borough of Wednesbury.

The petty sessional divisions of Wolverhampton, Kingswinford and Wordsley, Kowley Regis, Tipton, Wednesbury, Bilston, Dudley (Staffs), and Rushall; and the parishes of Brewood, Featherstone, Shareshill (including its detached part) and Hilton.

In the county of Worcester.

The county borough of Dudley;

The boroughs of Kidderminster, Stourbridge, Bewdley and Droitwich;

The petty sessional divisions of Oldbury, Halesowen, Stourbridge, Kidderminster, Stourport, Hundred House (except the parishes of Stanford on Teme, Shelsley Walsh, Martley, Clifton upon Teme and Lower Sapey), Droitwich, Redditch (except the parish of Inkberrow) and Bromsgrove; and the parishes of Bayton, Mamble, Lindridge, Orleton, Holt, Grimley, Ombersley and Martin Hussingtree.

In the county of Salop.

The borough of Bridgnorth;

The petty sessional divisions of Cleobury Mortimer (except the parishes of Silvington, Wheathill, Loughton and Burwarton), Brimstree (except the parishes of Cleobury North, Ditton Priors, Stanton Long, Monk Hopton and Acton Round), and Shifnal (except the parishes of Kemberton, Priorslee, Shifnal and Tong).

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES. (DATED 7TH JULY, 1926.)

FOOT - AND - MOUTH DISEASE (MON-TAGUE STREET (BIRMINGHAM) PIG MARKET) ORDER OF 1926.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Market to which this Order applies.

1. The Pig Market at Montague Street in the city of Birmingham, is hereby authorised

by the Minister of Agriculture and Fisheries to be used for the purposes of this Order, provided that whilst being so used no animals shall be kept in or moved into the market other than swine moved with a licence under this Order.

Movement of Swine to Market.

2. Swine intended for immediate slaughter may, notwithstanding the provisions of any Order made by the Minister restricting the movement of animals into an Infected Area, be moved to the market to which this Order applies with a licence granted by the Local Authority of the city of Birmingham, provided that no such licence shall be granted unless the owner of the swine shall sign and give to the Local Authority an undertaking in the form set out in the Schedule to this Order.

Removal of Swine from Market.

3. Swine moved to the market to which this Order applies with a licence granted under this Order shall not be moved therefrom except with a licence of an Inspector of the Local Authority of the city of Birmingham or to any place other than a slaughterhouse or bacon factory approved by the Inspector and situate in the area to which the Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 86) or any Order amending that Order for the time being applies, provided that no such licence shall be granted unless the owner of the swine shall sign and give to the Local Authority an undertaking in the form set out in the Schedule to this Order, and also provided that no such licence shall be deemed to authorise the movement of any animals out of the said Area.

Detention and Slaughter.

4. Swine moved to a slaughterhouse or bacon factory with a licence under this Order, shall be there detained until they are slaughtered, and shall be slaughtered within 36 hours after their arrival.

Undertakings to be Transmitted to Ministry.

5. The undertakings when received by the Local Authority shall be forthwith transmitted to the Ministry of Agriculture and Fisheries.

Conditions of Movement.

6. Swine moved under this Order shall be moved by the nearest available route and without unnecessary delay to the place of destination specified in the licence and not elsewhere, and shall so far as practicable be kept separate from all animals which are not being moved or have not been moved with a licence under this Order.

Licences.

7. Movement licences granted under this Order shall, unless a shorter period is therein specified by the Inspector granting the same, be available for six days including the day of the date thereof and no longer.

Short Title.

8. This Order may be cited as the FOOT-AND-MOUTH DISEASE (MONTAGUE STREET (BIRMING-HAM) PIG MARKET) ORDER OF 1926, and shall be read with the Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 86) and any Order amending that Order.
