Notice is hereby given, in pursuance of Section 49 (3) of the Diseases of Animals Act, 1894, that the Minister of Agriculture and Fisheries has made Orders declaring the following places to be infected with Foot-and-Mouth Disease.

Date.	Subject.
1926. 15th July ... ..	<i>Cheshire.</i> The buildings and lands known as Fields Farm, in the occupation of John Simpson Darlington, in the parish of Warmingham, in the administrative county of Chester.
17th July ... ..	<i>Lanarkshire.</i> The whole of the buildings and lands which lie to the south-west of the road leading from Crossford to Rosebank, and known as Dalpatrick Farm, in the occupation of Joseph Goulding, in the parish of Dalserf, in the administrative county of Lanark.
19th July ... ..	<i>Cheshire.</i> The whole of the buildings, premises and fields known as Iron Stile Farm, Stoneley Road, in the occupation of Frank Humphreys, in the parish of Church Coppenhall, in the administrative county of Chester.
	<i>Lanarkshire.</i> 1. The whole of the buildings and lands known as Waygateshawhead Farm, in the occupation of James Aithie, in the parish of Carluke, in the administrative county of Lanark. 2. That part of Upper Shieldhill Farm known as Station Field, in the occupation of Alexander Paterson, in the parish of Carluke, in the administrative county of Lanark. 3. The buildings and fields at 25, James Street, the fields known as Kirkton Fields, Carnwath Road, and the fields known as The Glebe, all in the occupation of Andrew Burnett, in the parish of Carluke, in the administrative county of Lanark.
20th July ... ..	<i>Lanarkshire.</i> The farm lands and buildings known as Woodside Farm, in the occupation of Alexander Binnie, in the parish of Lesmahagow, in the administrative county of Lanark.
