## ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 15th July, 1926.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Bicester Registration of Births, &c. (Alteration of Sub-districts) Order, 1926, and shall come into operation on the 1st day of August, 1926.

2. The existing Bicester Sub-district of Bicester Registration District shall be

extended by the addition of Bletchington Sub-district of the same Registration District and the extended Sub-district shall be known by the name of the Bicester Subdistrict.

3. The Registrar of the existing Bicester Sub-district shall be the Registrar of that Sub-district as extended by this Order.

# ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

And whereas the Essex (Wanstead and Woodford Urban Districts) Confirmation Order, 1926, which took effect on the 1st April, 1926, provided that part of the Parish of Wanstead should be transferred to the Parish of Woodford and part of the Parish of Woodford should be transferred to the Parish of Wanstead.

And whereas it is expedient that corresponding alterations should be made in the boundaries of the Registration Sub-districts hereinafter mentioned.

1. This Order may be cited as the West Ham Registration of Births etc. (Alteration of Sub-districts) Order, 1926, and shall come into operation on the 1st day of August, 1926.
