Notice is hereby given that the Minister of Transport by virtue and in exercise of the powers given to him by Section 7 of the London Traffic Act, 1924, the London Traffic (Restricted Streets) Regulations, 1925, the London Traffic (Restricted Streets) (No. 2) Regulations, 1925, and the London Traffic (Restricted Streets) (No. 3) Regulations, 1925, after consulting the London and Home Counties Traffic Advisory Committee, has relaxed the restrictions and limitations imposed by Regulation 2 of each of the said Regulations upon the occasion of the Fete and Flower Show to be held at Abridge, on Thursday, the 29th day of July, 1926, so that nothing in the said Regulations shall prevent any person who is maintaining at the date of this Notice a regular service in accordance with Section 6 of the London Traffic Act, 1924, upon the approved route numbered 10A from using on that day, after noon, in any of the streets or parts thereof between Stratford Broadway and Abridge declared to be "restricted streets" by the London Traffic (Restricted Streets) Order, 1925, the London Traffic (Restricted Streets) (No. 2) Order, 1925, and the London

Traffic (Restricted Streets) (No. 3) Order, 1925, and forming part of that approved route such number of omnibuses, in addition to those now used in the maintenance by him of any service or services on any approved route as may be necessary to enable him to maintain a total service of 3 omnibuses per hour in each direction on that part of approved route No. 10A which lies between Stratford Broadway and Abridge; provided that nothing herein contained shall be deemed to effect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give direction to constables for keeping order and for preventing any obstruction of the thoroughfares.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

FOOT-AND-MOUTH DISEASE DECLARA-TION OF INFECTED AREAS ORDER OF 1926 (No. 89).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Further Extension of Certain Infected Area.

1. The Foot-and-Mouth Disease Declaration of Infected Areas Order of 1926 (No. 74), as amended by any subsequent Order, shall be read and have effect as if the Area described in the Schedule to this Order were substituted for the Infected Area (No. 1) described in the First Schedule to that Order.

Short Title.

2. This Order may be cited as the Foot-AND-MOUTH DISEASE DECLARATION OF INFECTED AREAS ORDER OF 1926 (No. 89).
