Provided that no Hackney Carriage shall be suffered to stand across any Street or Thoroughfare, or opposite the end of any Street or Carriageway, or upon any place where Foot Passengers usually cross the Carriageway.

#### TRADE BOARDS ACTS, 1909 AND 1918.

##### VARYING AND FIXING OF MINIMUM RATES OF WAGES IN THE PERAMBULATOR AND INVALID CARRIAGE TRADE.

The Perambulator and Invalid Carriage Trade Board (Great Britain) have issued a Notice dated 20th August, 1926, setting out all the Minimum Rates of Wages in operation under the Trade Boards Acts for workers engaged in the trade (including the minimum rates fixed for workers brought within the scope of the trade for the first time by the Trade Boards (Perambulator and Invalid Carriage) Order, 1926, and also certain variations in the minimum rates previously in operation which have been confirmed by Order of the Minister of Labour to take effect as from 23rd August, 1926).

#### TRADE BOARDS ACTS, 1909 AND 1918.

##### RETAIL BESPOKE TAILORING TRADE BOARD (ENGLAND AND WALES).

PROPOSAL TO VARY AND FIX MINIMUM RATES OF WAGES FOR CERTAIN CLASSES OF MALE AND FEMALE WORKERS IN THE AREAS COMPRISING (1) THE COUNTIES OF BERKSHIRE, OXFORDSHIRE, BUCKINGHAMSHIRE AND HERTFORDSHIRE (EXCLUDING THE METROPOLITAN POLICE AREA), (2) THE COUNTIES OF STAFFORDSHIRE, WORCESTERSHIRE, WARWICKSHIRE, NORTHAMPTONSHIRE, GLOUCESTERSHIRE (EXCEPT THE COUNTY BOROUGH OF BRISTOL) AND HEREFORDSHIRE.
