

tions and limitations imposed by Regulation 2 of each of the said Regulations upon the occasion of the Carnival and Fête to be held at Romford, on Saturday, the 21st day of August, 1926, so that nothing in the said Regulations shall prevent any person who is maintaining at the date of this Notice a regular service in accordance with Section 6 of the London Traffic Act, 1924, upon the approved route numbered 186A from using on that day between the hours of 12 noon and 10 p.m. in any of the streets or parts thereof declared to be "restricted streets" by the London Traffic (Restricted Streets) Order, 1925, the London Traffic (Restricted Streets) (No. 2) Order, 1925, and the London Traffic (Restricted Streets) (No. 3) Order, 1925, and forming part of that approved route such number of omnibuses, in addition to those now used in the maintenance by him of any service or services on any approved route as may be necessary to enable him to maintain an additional service of 4 omnibuses per hour in each direction on that approved route; provided that nothing herein contained shall be deemed to affect or derogate from the powers of the Commissioner of Police of the Metropolis under the provisions of Section 52 of the Metropolitan Police Act, 1839, to give direction to constables for keeping order and for preventing any obstruction of the thoroughfares.

SALMON AND FRESHWATER FISHERIES ACT, 1923.

FRESHWATER FISHERIES (WYE FISHERY DISTRICT) ORDER, 1926.

The Minister of Agriculture and Fisheries has made the above Order under Section 65 of the Salmon and Freshwater Fisheries Act, 1923. The effect of the Order is to extend to "freshwater fish" within the District the provisions of Sections 61 to 64 of the Act relating to licences and licence duties, and to render it an offence against the Act for any person to take freshwater fish otherwise than by means of an instrument which he is duly licensed to use for the purpose.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 18TH AUGUST, 1926.)

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power

enabling him in this behalf, hereby orders as follows:—

Authorisation of Landing in Great Britain of Bactrian Camels from Germany.

1. The landing of the animals described in the First Schedule hereto is hereby allowed, subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purpose of the landing and detention of the animals under this Order.

Regulations Applicable to Animals before and on Landing.

3. (1) The animals shall not be landed in Great Britain unless and until there are delivered to a proper officer of Customs and Excise the certificates prescribed by this Article, namely:—

(a) A certificate signed by an Officer of the German Government to the effect that the camels to be imported have, for a period of six weeks prior to shipment, been quarantined with bovine animals, and that during that period and at the time of shipment to this country, the camels and the bovine animals showed no evidence of foot and mouth disease, contagious pleuro-pneumonia and cattle plague.

(b) A certificate, which shall accompany the animals, signed by an Officer of the German Government to the effect that the camels have been moved by water from the barge on the River Elbe on which the animals are quarantined in Germany direct to the exporting vessel for shipment to this country.

(2) The camels, before being landed, shall be examined by a Veterinary Inspector of the Ministry, and if found by him to be free from symptoms of contagious disease, shall forthwith be landed and moved under the supervision of the Inspector from the place of landing direct to the Foreign Animals Quarantine Station described in the Second Schedule hereto.

(3) The animals shall be detained in the said Quarantine Station until the expiration of a period of twenty-eight days after their arrival therein.

(4) Whilst detained in the said Quarantine Station the animals shall be under the control of a Veterinary Inspector appointed by the Ministry.

(5) During such period of detention no other animals shall be moved into the said Quarantine Station, and the animals landed under this Order shall be kept separate from all other animals.
