PUBLIC HEALTH ACTS AMENDMENT ACT, 1907.
 PUBLIC HEALTH ACT, 1925.

BY an Order taking effect on the 20th day of September, 1926, the Minister of Health has (1) declared that the provisions of Part VI of the Public Health Acts Amendment Act, 1907, and Part VI of the Public Health Act, 1925, shall be in force in the City of Carlisle, and (2) repealed Part III of the Carlisle Corporation Act, 1904, so far as it relates to the same subject matter as Part VI of the Act of 1907 aforesaid.
