

TRAINING SHIP " CORNWALL,"

OFF DENTON, GRAVESEND.

The Secretary of State for the Home Department hereby gives notice that the Training Ship " Cornwall " having been removed from a berth off Purfleet to moorings off Denton, Gravesend, he has issued a new Certificate that the Training Ship " Cornwall," lying off Denton, Gravesend, is fit for the reception of boys sent to a Reformatory School in pursuance of the provisions of the Children Act, 1908.

The Certificate, which bears date the 24th September, 1926, provides that the number of boys resident in the said Training Ship at any any one time, whether sent thereto in pursuance of the said provisions or not, shall not exceed two hundred.

JUTE TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO VARY MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS.

In accordance with Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour, and dated 31st October, 1918, 1st August, 1922, and 1st April, 1926 respectively, the Jute Trade Board (Great Britain) HEREBY GIVE NOTICE that they PROPOSE TO VARY the General Minimum Time Rates, Piece Work Basis Time Rates, Guaranteed Time Rates, General Minimum Piece Rates and Overtime Rates for male and female workers set out in the Notice J. (39) issued by the Jute Trade Board (Great Britain) and dated 6th June, 1925.

Particulars of the Minimum Rates proposed are available for inspection at the address shown below, or may be obtained on application to the Secretary of the Trade Board.

Under Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will CONSIDER ANY OBJECTIONS to the above Proposal to Vary which may be lodged with them within two months from the 28th day of September, 1926. Such Objections should be in writing and signed by the person making the same (adding his or her name and address) and should be sent to the Secretary, Jute Trade Board (Great Britain), 1, Whitehall Gardens, London, S.W. 1.

It is desirable that Objections should state precisely and, so far as possible with reasons, what is objected to.
