

SCHEDULE.

Toys containing lace.

Nick nacks and fancy articles containing lace when the value of such nick nacks or fancy articles does not exceed the value of thirty shillings a dozen.

ORDER dated September 25th, 1926, made by the Treasury under Section 12 of the Finance Act, 1926.

Whereas sub-section (1) of Section 12 of the Finance Act, 1926, provides that the Treasury may by order exempt any articles mentioned in the order which are liable to duty under the Safeguarding of Industries Act 1921 as amended by that Act from that duty if they are satisfied that, having regard to the nature or small value of the articles it is inexpedient that the duty should be charged.

And whereas, having regard to the nature or small value of the articles specified in the Schedule to this Order, it appears to the Treasury, after consultation with the Board of Trade, that it is inexpedient that duty should be charged under the Safeguarding of Industries Act, 1921, as amended by the Finance Act, 1926, on those articles.

Now, therefore, we, being two of the Lords Commissioners of His Majesty's Treasury, in pursuance of the powers conferred on us by the said Section 12 of the Finance Act, 1926, hereby order as follows:—

The articles mentioned in the Schedule to this Order shall be exempt from the duty imposed on the said articles by the Safeguarding of Industries Act, 1921, as amended by the Finance Act, 1926.

Complete binoculars, telescopes and amicos not exceeding a value of one shilling and sixpence each.

Complete optical lanterns not exceeding a value of two shillings each.

Complete cinematographs not exceeding a value of three shillings each.
