## TRADE BOARDS ACTS, 1909 AND 1918.

# PAPER BOX TRADE BOARD (GREAT BRITAIN).

PROPOSAL TO FIX MINIMUM RATES OF WAGES FOR MALE AND FEMALE WORKERS IN THOSE BRANCHES OF THE TRADE NEWLY BROUGHT WITHIN THE SCOPE OF THE TRADE BY THE TRADE BOARDS (PAPER BOX) ORDER, 1925.

In accordance with the Regulations made under Section 18 of the Trade Boards Act, 1909, by the Minister of Labour and dated 31st October, 1918, 1st August, 1922, and 1st April, 1926, respectively, the Trade Board established under the Trade Boards Acts, 1909 and 1918, in Great Britain for the Paper Box Trade as specified in the Appendix to the Trade Boards (Paper Box) Order, 1925. HEREBY GIVE NOTICE that they PRO-POSE TO FIX minimum rates of wages for male and female workers (including female home-workers) by providing that the minimum rates of wages set out in the Schedule to the Trade Board's Notice B. (11), dated 1st March, 1924, which are already in operation, for the "Cost of Living" Periods specified in that Notice, as respects workers employed in those branches of the Trade included under paragraph 2 of the Schedule to the Trade Boards Act, 1909, which are also included by the Trade Boards (Paper Box) Order, 1925, shall apply in the same manner and for the same periods, to workers of the same classes who are employed in those branches of the Paper Box Trade included by the Trade Boards (Paper Box) Order, 1925, which are not included under paragraph 2 of the Schedule

to the Trade Boards Act, 1909. Pursuant to Section 3 (5) of the Trade Boards Act, 1918, the Trade Board will con-sider any OBJECTIONS to the above Proposal to Fix which may be lodged with them within two months from 19th October, 1926. Such objections should be in writing and signed by the person making the same (adding his or her full name and address) and should be sent to the Secretary, Paper Box Trade Board (Great 1, Britain), Whitehall Gardens, London, S.W. 1.

It is desirable that Objections should state precisely and, so far as possible, with reasons, what is objected to.
