ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 20th October, 1926.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-districts:

And whereas by the Bristol Corporation Act, 1926, the boundaries of the City of Bristol were extended on the 1st October, 1926, so as

to comprise part of the parish of Henbury and part of the parish of Portishead.

And whereas it is expedient that corresponding alterations should be made in the constitution of the Registration Sub-districts hereinafter mentioned:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Bristol, Thornbury and Long Ashton Registration of Births etc. (Alteration of Sub-districts), Order, 1926, and shall come into operation on the 1st day of November, 1926.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The part of the Civil Parish of Henbury which was added by the recited Act to the City and Civil Parish of Bristol shall cease to form part of the Almondsbury Subdistrict of Thornbury Registration District and shall be added to and form part of the Westbury on Trym Sub-district of Bristol Registration District.

4. The part of the Civil Parish of Portishead which was added by the recited Act to the City and Civil Parish of Bristol shall cease to form part of the St. George Sub-district of Long Ashton Registration District and shall be added to and form part of the Bedminster Sub-district of Bristol Registration District.

5. The Superintendent Registrar of the existing Bristol Registration District shall be the Superintendent Registrar of that Registration District as extended by this Order

6. The Registrars of the existing Subdistricts of Westbury on Trym and Bedminster shall be, respectively, the Registrars of those Sub-districts as extended by this Order.
