FOREIGN HAY AND STRAW (AMEND-MENT) ORDER OF 1926 (No. 2).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Prohibition of Landing of Hay and Straw from Norway.

 Hay and straw brought from Norway shall be subject to the prohibition of landing contained in the Foreign Hay and Straw Order of 1912.

Commencement.

2. This Order shall take immediate effect, provided that such prohibition shall not apply to hay or straw shipped from Norway before the date of this Order.

Short Title.

3. This Order may be cited as the Foreign Hay and Straw (Amendment) Order of 1926 (No. 2).
