ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

FOOT-AND-MOUTH DISEASE (DE-CLARATION OF INFECTED AREAS) ORDER OF 1926 (No. 122).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Release of Shropshire Infected Area from Restrictions.

1. The Foot-and-Mouth Disease Infected Area (No. 2) described in the First Schedule to the Foot-and-Mouth Disease (Declaration of Infected Areas) Order of 1926 (No. 116) shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925.

Commencement and Short Title.

2. This Order shall come into operation on the seventeenth day of November, nineteen hundred and twenty-six, and may be cited as the FOOT-AND-MOUTH DISEASE (DECLARATION OF INFECTED AREAS) ORDER OF 1926 (No. 122).
