ELECTRIC DETONATORS.

The Secretary for Mines gives notice that on the 10th November he made an Order, in pursuance of Section 61 of the Coal Mines Act, 1911, to the effect that no detonator other than an electric detonator in a copper capsule shall be used in mines in which the use of "Permitted Explosives" is compulsory under the Explosives in Coal Mines Order of the 1st September, 1913.
