#### MINISTRY OF HEALTH.

THE BOARDS OF GUARDIANS (ORDERS OF REMOVAL) ORDER, 1926, DATED NOVEMBER 10, 1926, MADE BY THE MINISTER OF HEALTH.

Whereas by the Union Chargeability Act, 1865, it is provided that boards of guardians of unions may obtain orders of removal and may defend appeals against such orders, in like manner and subject to the like incidents and consequences as in the case of orders of removal obtained by overseers, and under section 25 of the Divided Parishes and Poor Law Amendment Act, 1876, the board of guardians of a parish, when authorised by the Minister of Health, may apply for orders of removal, and defend appeals against orders of removal, in the place of the overseers, and with the like powers and subject to the like liabilities as the board of guardians of a union, but the boards of guardians of certain parishes have not under that section been so authorised;

And whereas subsection (1) of section 62 of the Rating and Valuation Act, 1925, directs that after the 1st day of April, 1927, overseers shall cease to be appointed, and it is expedient that further provision should be made as hereinafter mentioned:

Now therefore, the Minister of Health, in pursuance of his powers under section 25 of the Divided Parishes and Poor Law Amendment Act, 1876, and of any other powers enabling him in that behalf, hereby orders as follows:—

1.—(1) This order may be cited as the Boards of Guardians (Orders of Removal) Order, 1926, and shall come into operation on the 1st day of April, 1927.

(2) This order shall extend to England and Wales, inclusive of the administrative county of London.

(3) The Interpretation Act, 1889, applies to the interpretation of this order as it applies to the interpretation of an Act of Parliament.

2. The Minister hereby authorises every board of guardians of a parish, who are not by virtue of any local Act or order entitled to exercise the powers and made subject to the liabilities of overseers which are mentioned in section 25 of the Divided Parishes and Poor Law Amendment Act, 1876, to apply for
