orders of removal, and to defend appeals against any such orders obtained, in the place of the overseers of the poor of the parish, and with the like powers and subject to the like liabilities as guardians of a union are entitled or are subject to in respect of such orders.

3.—(1) If immediately before the 1st day of April, 1927, any legal proceeding is pending or existing by or against the overseers of a parish in relation to an application for an order of removal, or to an order of removal, the same shall not be prejudicially affected by reason of this order, but may be continued and enforced by or against the board of guardians of that parish.

(2) All legal proceedings pending immediately before the 1st day of April, 1927, may be amended in such manner as may be necessary or proper in consequence of this order.

For the purposes of the Electricity (Supply) Acts, 1882 to 1922, and all Orders and Licenses made or granted and issued thereunder, and any Local Act relating to the supply of electricity, the Electricity Commissioners approve of the construction and pattern of the meter (hereinafter described) for the measurement of electrical energy when supplied on the constant pressure two-wire single phase alternating current system, and known as the "Sangamo" Type S. 2 Induction Watthour Meter, rated sizes 2.5 amperes to 25 amperes inclusive, 110 to 550 volts inclusive, at 50 cycles per second.

Provided that the meter be constructed as described in the specification and drawings deposited at the National Physical Laboratory, Teddington, Middlesex, dated and numbered 5th November, 1924, and No. 109, and be in accordance with one of the pattern meters Nos. 2576846, 2369044, 2369046, 2369047, 2783994, 2783995 and 2369045, deposited at the National Physical Laboratory on the 11th April, 1924, 3rd December, 1924, and the 24th July, 1925, respectively, by or on behalf of the British Sangamo Company, Limited, Ponders End, Middlesex, and sealed by the National Physical Laboratory at the instance of the Electricity Commissioners.

The Electricity Commissioners further approve of the means provided for fixing meters of this description, and for connecting them with the service lines as described in the specification and drawings above

referred to.

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Authorisation of Landing of Animal for Exceptional Purposes.

1. The landing of the animal described in the First Schedule hereto, which is intended for exceptional purposes, is hereby allowed, subject to the provisions of Part II (Quarantine) of the Third Schedule to the Diseases of Animals Act, 1894, and of the Foreign Animals (Quarantine) Order of 1896, and of this Order.

Definition of Quarantine Station.

2. The premises described in the Second Schedule hereto are hereby defined as a Foreign Animals Quarantine Station for the purposes of the detention of the animal described in the First Schedule hereto.

Examination before Landing.

3. No such animal as aforesaid shall be landed except with a licence granted by an Inspector of the Ministry, which licence shall not be granted unless and until the animal has been examined by a Veterinary Inspector of the Ministry and certified by him to be free from symptoms of contagious disease.

Regulations Applicable to the Animal on Landing.

4. The animal on being landed, shall forthwith be moved under the supervision of an Inspector of the Ministry of Agriculture and Fisheries from the quay to the premises described in the Second Schedule hereto, and shall be there detained for a period of twenty-eight days. During the said period the animal shall be kept separate from all other animals, and no other animals shall be moved into such premises.
