

course; the application to the Corporation in respect of their water undertaking of the powers of a local authority under Section 54 of the Public Health Act, 1875, with respect to the carrying of water mains within and without their district and the erection of houses by the Corporation for the purposes of the said undertaking and for providing accommodation in substitution for buildings vacated in consequence of the Bill.

Provisions with regard to the supply of water by the Corporation to buildings used partly for business or trade or certain other purposes; for increasing guarantees under section 35 of the Waterworks Clauses Act, 1847, and for enabling local authorities to enter into guarantees and contracts relative to the supply of water to premises supplied or to be supplied by the Corporation.

The construction maintenance and use in connection with the supply of water to the Electricity generating station of the Corporation in the Urban District of Newton Abbot the following works in that district:—

An intake from the River Teign with a pumping station on the right bank of that River and a delivery culvert or pipe commencing in the pumping station and terminating in the said generating station and a culvert or pipe with outlet into the River Lemon commencing in the said generating station and terminating on the right bank of the River Lemon.

The abstraction by the Corporation of water from the River Teign and user thereof for any purposes in connection with their electricity undertaking and return into the River Lemon of such water or so much thereof as shall not be used at the generating station.

The construction of street works in the following roads in the Borough:—

Widenings of Babbacombe Road, St. Mary Church Road, with roundings off of corners of Westhill Avenue and Haytor Road. Widenings of Westhill Road and the rounding off of corners of St. Margarets Avenue. A widening of Teignmouth Road, a widening of Avenue Road with the rounding off of corners of Falkland Road and Walnut Road. Improvements in and at the junctions of Meadfoot Road, Middle Woodfield Road and Park Hill Road. A widening of Petitor Road. Widenings and rounding off of corners of Warborough Mount Road. A widening of Reddenhill Road. Widenings of Torbay Road and a rounding off of the corners at the junction with the footpath leading under the railway to Wheatridge Lane and the corner of Cliff Road and a widening of Higher Union Street.

The breaking up and interference with highways, bridges, tunnels, navigations, rivers sewers, drains, pipes, wires and other works; and underpinning of premises.

The acquisition by compulsion or agreement of lands in the above mentioned parishes and of lands in the Parish of Lydford in the Rural District of Tavistock adjoining the said weir pool.

The acquisition or user of common lands and parts of Chagford Common and Stiniel Down in the Parish of Chagford aforesaid.

The acquisition by compulsion or agreement of the following lands in the Borough:—

(a) for the purpose of playing fields for school children a piece of land containing 4 acres 1 rood or thereabouts being part of Enclosures Nos. 9 and 34 on the 25 inch Ordnance Map Devon Sheet CXVI-10 (Second Edition 1904).

(b) for the purpose of a recreation ground or playing fields lands bounded by Old Mill Road Walnut Road Avenue Road and the Great Western Railway (Torquay Branch) now in lease to the Devon Rosery Company Limited.

The modification of provisions of the Lands Clauses Acts.

The acquisition by Agreement of Torbay Hospital and lands occupied or enjoyed therewith in the Borough and sale or leasing by the Trustees or other persons in whom those premises and lands are vested or who have rights and interests therein, and the adaptation equipment and use, of the said premises for Public Libraries, Museums, Schools of Science, Art Galleries, Schools of Art, Municipal and other Offices and other purposes.

The acquisition by agreement and improvement and development of the area lying between Vaughan Parade, Vaughan Road, Cary Green Road, Lawrence Place and the Strand in the Borough and the stopping up of Palk Street and the open space between that street and Cary Green Road and extinguishment of rights of way thereover.

Provisions for the acquisition by agreement of other lands, and retention and disposal of same.

Provisions enabling the Corporation, under Section 11 of the Development and Road Improvement Funds Act 1909, to acquire lands required for roads within and without the Borough for which they are or may be the responsible authority under any scheme formulated under the Town Planning Act 1925 and further lands abutting upon any such road for the purposes of development and enabling the Corporation to develop such last mentioned lands, and application of the provisions of the said Act of 1909 accordingly, or the enactment of other enabling provisions in that behalf.

Increase and other alterations of Harbour duties rates dues tolls and charges and fixing of new duties rates dues tolls and charges to be taken in connection with the Harbour undertaking of the Corporation and compositions and exemptions from payment thereof.

Borrowing powers; provisions for utilisation of moneys in loans fund, sinking fund, reserve fund and other funds of the Corporation and revenue moneys for working capital.

Prohibition of distribution of handbills, and touting and hawking, and of erection of buildings on front land except in accordance with approved elevations.

Duplicate plans and sections showing the lines situations and levels of the proposed works and the lands in through or over which they will be made or which may be compulsorily taken or used for the construction thereof and plans showing the lands which may be compulsorily taken or used for other
