and Section 92 of the Lands Clauses Consolidation Act, 1845.

- 7. The enactment of special provisions for determining compensation payable in respect of lands acquired by the Corporation including provisions as to betterment, buildings recently erected, and interests recently created and of provisions as to entry on lands for the purposes of survey.
- 8. Extending the time limited by the Croydon Corporation Act 1924 for the compulsory purchase of lands required for and in connection with the street works authorised by that Act.
- 9. Empowering the Corporation to erect buildings upon the lands acquired by them under the Bill or belonging to them and adjoining the street works to be authorised by the Bill and to develop such lands or grant building and other leases thereof and to advance money or assist financially purchasers or lessees of such land; to confer further powers upon the Corporation with reference to surplus lands.
- 10. The enactment of further provisions with regard to the electricity undertaking of the Corporation including provisions as to the sale of electrical fittings and the wiring of houses by the Corporation; the establishment of show rooms; the giving of demonstrations; the method of charging and recovery of charges for fittings and wiring; the cutting off of supplies and recovery of costs thereof; supply of electricity by agreement; notice of discontinuance; power to refuse to supply under certain circumstances; recovery charges for re-connection of premises; maximum power to be demanded; improper use of supplies for power purposes; attachment of brackets to buildings; construction of substations under streets; laying of mains in private streets; period of error in defective meters; further powers of entry on premises; bye-laws as to apparatus and fittings; inclusion in limits of supply of boundary roads; supply of electricity in bulk; application of revenue and other matters.
- 11. The prohibition of selling articles from stationary barrows, carts, stalls or other receptacles in streets except under authority of a licence from the Corporation; provisions as to applications for and the granting, refusal, renewal and revocation of such licences and the fees payable therefor and as to attachment of conditions; the making of bye-laws and the recovery of charges for the performance of certain services.
- 12. The enactment of further provisions with regard to streets, fences and lands at terminations of new streets, buildings, advertisements, advertisement hoardings, drains, infectious disease and sanitary matters and generally with regard to the good rule and government of the borough.
- 13. Empowering the Corporation to erect or acquire public halls and other buildings and conferring further powers with regard to parks, recreation grounds and lands belonging to the Corporation, and the erection of buildings therein and thereon.
- 14. The extension to open spaces acquired by the Corporation under the Open Spaces Act 1906 of their powers with regard to parks and pleasure grounds including powers for the

erection of buildings and the setting apart of such open spaces for games.

- 15. Empowering the Corporation to purchase dwelling-houses for persons employed by them and offices and buildings for their several undertakings and to erect fit up and let the same.
- 16. The borrowing of money by the Corporation for the purposes of the Bill and other financial matters including provisions for authorising the issue by the Corporation of a new class of stock.
- 17. The incorporation, repeal and application of the Corporation's Acts and Orders and the enactment of such provisions as may be incidental to the objects of the Bill or consequential thereon.

A map in duplicate showing as well the present boundaries of the Borough as the boundaries of the proposed alteration thereof will, on or before the 30th day of November instant, be deposited with the Town Clerk of the Borough at the Town Hall, Croydon.
