

11. The regulation of the Whitmore Park and Holbrook Lane Hostels of the Corporation and the lands adjacent to those hostels and the provision, maintenance and letting of sheds and other similar buildings on the Corporation's Housing Estates.

12. The abolition of any rights over Stoke Common in the city and the parishes of Stoke and Wyken in the rural district of Foleshill and the parish of St. Michael Without Coventry in the rural district of Coventry all in the county of Warwick, Whitley Common in the said parish of St. Michael Without Coventry, Hearsall Common in the city and in the parish of Stoneleigh in the rural district of Warwick in the county of Warwick, Radford Common in the city and Stivichall Common in the parish of Stivichall in the said rural district of Warwick, and the maintenance of the said commons as recreation grounds or open spaces or, in the case of Whitley Common, for some public purpose sanctioned by Parliament, and the conferring of other powers with regard to the said commons. The said commons are shown on the deposited plans hereinafter referred to and are more particularly described in the notice published in the newspaper named in the final paragraph of this notice.

13. The declaration and redefinition of the qualifications for obtaining the freedom of the city, and the enactment of provisions relating to the said freedom and the admission and enrolment of freemen.

14. The borrowing of money for all or any of the purposes of the intended Act, and the enactment of other financial provision, including the formation of a "Capital Fund" for the purpose of making advances to any of the Corporation's capital accounts, and for any purpose for the benefit, development and improvement of the city, the issue of bonds and the establishment of an insurance fund.

15. The repeal, amendment, and incorporation of Public and Local Acts and Orders relating to the city, the corporation and the Kenilworth Gas Company.

Plans and sections of the intended works and plans of the lands (including the Commons over which rights are to be extinguished) intended to be taken together with a Book of Reference to the plans will on or before the 30th day of November instant be deposited for public inspection with the Clerk of the Peace for the County of Warwick at his office at Leamington, and on or before the said 30th day of November a copy of so much of the said plans, sections and book of reference as relates to the city will be deposited with the Town Clerk at the Town Clerk's office in the city, as relates to the rural district of Foleshill with the Clerk to the Foleshill Rural District Council at his office at Foleshill, as relates to the rural district of Coventry with the Clerk to the Coventry Rural District Council at his office in the city, as relates to the rural district of Warwick with the Clerk to the Warwick Rural District Council at his office at Leamington, as relates to the parish of Stoke with the Clerk to the Parish Council of that parish at his office at 14, First Avenue, Copsewood, Stoke, as relates to the parish of Wyken with the Chairman of the parish meeting of that parish at his residence at Caludon Farm, Wyken, as relates to the parish of St. Michael

Without Coventry with the Chairman of the parish meeting of that parish at his residence at 6 and 7, Moat Street, in the city, as relates to the parish of Stoneleigh with the Clerk to the Parish Council of that parish at his office at Stoneleigh, and as relates to the parish of Stivichall with the Chairman of the parish meeting of that parish at his residence at Stivichall Hall, near Coventry.

#### COLCHESTER CORPORATION.

NOTICE is hereby given that application is intended to be made to Parliament in the Session 1927 by the Mayor Aldermen and Burgesses of the Borough of Colchester (hereinafter called "the Corporation" and "the borough" respectively) for an Act and that the following will be the principal subject matters of the Bill for such Act:—

1. The provision equipment and working of trolley vehicles by the Corporation along the following routes in the borough, namely:—

Route No. 1.—Commencing at the junction of Mile End Road and Bergholt Road passing along North Station Road, North Bridge, Middleborough, North Hill, Head Street, Headgate, Crouch Street, Lexden Road, Lexden Street and London Road to and terminating at the borough boundary;

Route No. 1A.—Commencing at borough boundary in London Road, passing along King Coel Road and Halstead Road, to and terminating in London Road by a junction with route No. 1;

Route No. 2.—Commencing in High Street at its junction with North Hill and Head Street, passing along High Street, Queen Street, St. Botolph Street, St. Botolph's Corner, Magdalen Street, Barrack Street, Hythe Hill to and terminating at its junction with Hythe Quay Road;

Route No. 3.—Commencing in High Street at its junction with Queen Street, passing along High Street, East Hill, East Bay, East Bridge and East Street to and
