SUNDERLAND CORPORATION.

NOTICE is hereby given that application is intended to be made to Parliament in the ensuing session by the Mayor Aldermen and Burgesses of the borough of Sunderland (hereinafter called "the Corporation" and "the borough" respectively) for an Act of which the principal subject matters are as follows:—

1. To extend the borough so as to include therein the urban district of Southwick, the parishes of Fulwell, Ford and Bishopwearmouth Without (including Bishopwearmouth Without detached) and parts of the parishes of Tunstall and Ryhope in the rural district of Sunderland, part of the parish of Whitburn in the rural district of South Shields and part of the parish of Silksworth in the rural district

- of Houghton-le-Spring, all in the county of Durham. The parts of the parishes which are referred to are shown on the map deposited as hereinafter mentioned and are indicated in the notice published in the newspaper referred to in the final paragraph of this notice.
- 2. To abolish the Southwick Urban District Council and the parish councils of the existing parishes of Fulwell, Ford and Bishopwearmouth Without and to exclude the added areas from the jurisdiction of the Durham County Council, the South Shields, Houghton-lespring and Sunderland rural district councils and the Whitburn, Silksworth, Tunstall and Ryhope parish councils, to add the parish of Hylton to the South Shields rural district under the jurisdiction of the South Shields rural district council, and, if the parts of the parishes of Tunstall and Ryhope not included in the borough are united into an urban district, to provide for the dissolution of the Sunderland rural district council.
- 3. To exclude the added areas from the South Shields and Houghton-le-Spring Unions and to include them in the parish of Sunderland in the Sunderland Union.
- 4. To enact all necessary, convenient or consequential provisions with regard to such alterations and extensions including provisions as to local government elections; the number of councillors and aldermen of the borough and guardians of the parish of Sunderland; the alteration and increase of wards in the borough and of the parish of Sunderland; the allocation, election and retirement of councillors and aldermen and guardians; the extension of jurisdiction of officers of the Corporation and of justices, coroner and other peace officers; the alteration of county electoral divisions; the extension and amendment of local Acts and Orders etc; provisions for saving the rights of the Cleveland and County of Durham Electric Power Company in the added areas; the transfer of officers and abolition of offices and compensation for loss; the transfer of police and police stations, the transfer of schools; the adjustment of property; financial relations between bodies affected; alteration of North East Durham Joint Smallpox Hospital District and Board and representation thereon, and on any joint committee for tuberculosis; alteration of county insurance committees; extension of jurisdiction of Corporation as burial authority; the inclusion of the added areas in the assessment area of the borough and the variation of schemes with regard to the assessment areas of the County of Durham; provisions as to mortgage and to other debts of the councils in the added areas and the Corporation, the provisions debts, as liquidation of differential rating in the added areas, and other matters.
