tus for working trolley vehicles and adaptation of tramway apparatus; conveyance of passengers, parcels, luggage, animals and goods; tolls, rates, fares and charges; application of powers of the Corporation with reference to trolley vehicles or to their tramway undertaking.

Power to the Corporation and (as respects cmnibuses) the Keighley Corporation to enter into agreements for the working etc. of omnibuses or trolley vehicles and other matters incidental thereto; exemption of the Corporation and the Keighley Corporation from liability to claims for damage by extraordinary traffic in respect of omnibuses or trolley vehicles.

Power to the Corporation to run over and use certain trolley vehicle routes of the Lord Mayor Aldermen and Citizens of the City of Leeds (hereinafter referred to as "the Leeds Corporation") in the urban districts of Guiseley, Baildon, Otley and Burley-in-Wharfedale and the rural district of Wharfedale in the said West Riding; provisions as to user of equipment and supply of electricity; transfer to the Corporation of part of the trolley vehicle undertaking of the Leeds Corporation consisting of a trolley vehicle route in the said urban districts of Guiseley and Baildon and rural district of Wharfedale and powers to the Corporation with reference to the transferred portion of the said undertaking; agreements between the Corporation and the Leeds Corporation with reference to those matters.

CHEPPING WYCOMBE CORPORATION.

NOTICE is hereby given that application is intended to be made to Parliament in the Session 1927 by the Mayor Aldermen and Burgesses of the Borough of Chepping Wycombe (hereinafter called "the Corporation" and "the borough" respectively) for an Act of which the principal subject matters are as follows:—

1. The extension of the boundary of the borough and of the Parish of High Wycombe in the Wycombe Union so as to include within the boundary of the borough and that parish, portions of the parishes of Chepping Wycombe (Rural), Hughenden and West Wycombe (hereinafter called "the added areas") which portions are shown upon the map hereinafter mentioned and are more particularly described in the Notice referred to in the last paragraph hereof.

2. The exclusion of the added areas from the Wycombe Rural District and from the parishes of Chepping Wycombe (Rural) Hughenden, and West Wycombe respectively.

3. The enactment of all necessary, convenient, and consequential provisions with regard to such alteration and extension including provisions as to the election of councillorsand aldermen of the extended borough and guardians for the extended parish of High Wycombe; the division of the borough and parish into wards for the election of borough councillors and guardians and into electoral divisions for the election of county councillors; the extension of the jurisdiction of officers of the Corporation and other officers; the alteration of county electoral divisions; the extension and amendment of local Acts; the transfer of police and police buildings; thetransfer of schools; the adjustment of property and financial relations; and other matters.

4. The extension of the Corporation's limitsfor the supply of water so as to include the added areas and the alteration or repeal of the powers of the Rickmansworth and Uxbridge Valley Water Company Limited and the-Amersham, Beaconsfield and District Waterworks Company Limited to supply water inany part of the added areas. The alteration and repeal of the Rickmansworth and Uxbridge Valley Water Order, 1917, and the Amersham, Beaconsfield and District Water Orders and Act, 1896 to 1914.

The provision and running of omnibuses by the Corporation within the borough and beyond the borough with such consents as may be required under the provisions of the Bill, and the enactment of all necessary, convenient and incidental provisions with regard to the running of omnibuses including (amongst others) provisions as to fares, rates and charges, the acquisition of land by agreement, and working agreements.

The extinction of rights of pasturage or depasturage and other rights and interests exercisable over "The Rye Mead" in the borough (being Enclosure Nod. 148 on the $\frac{1}{2500}$ ordnance map of the borough (Edition of 1925) Sheets XLVII. 1 and 2) lying to the south of the river Wye and containing 30 176 acres or thereabouts by inhabitants and rated house dwellers in the borough; compensation for such extinction; the user of the Rye Mead as a pleasure ground or as land for games; the repeal of existing bye-laws relating to the Rye Mead; the making of other bye-laws by the Corporation and the enactment. of general provisions as to the maintenance, management and user of the Rye Mead.
