" And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the union of the said two Benefices based upon the terms recommended in the said Report:

'And whereas the said Benefice of Fosbury, Christ Church, is now full, the Reverend Reginald Callender being the present In-cumbent thereof, and the said Benefice of

Tidcombe is at present vacant:

"And whereas the said Reginald Callender has consented to become the first Incumbent of the United Benefice, if and when the union which is hereinafter recommended and pro-

posed shall take effect:

'And whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Tidcombe is vested in and is exercisable by the Dean and Canons of Your Majesty's Free Chapel of Saint George within Your Castle at Windsor (hereinafter called 'the Dean and Canons of Windsor') and the said Dean and Canons of Windsor are also the Patrons of the Benefice of Froxfield in the said County of Wilts and in the said Diocese of Salisbury:

"And whereas the Advowson or perpetual right of Patronage of and presentation to the said Benefice of Fosbury, Christ Church, is vested in and is exercisable by John Francis William Deacon, Esquire, of Number 20, Birchin Lane, in the City of London; the Reverend Ernest Newton Sharpe, of the Vicarage, Paddington, in the County of Middlesex, a Prebendary of the Cathedral Church of Saint Paul in London, the Very Reverend Henry Lawe Corry Vully de Candole, Dean of Bristol, the Reverend Prebendary Edward Grose Hodge, an Honorary Canon of Birmingham, and Edward Ranulph Kenyon, C.B., C.M.G., a Major General in Your Majesty's Army:

And whereas it appears to us the said Ecclesiastical Commissioners for the purpose of more conveniently carrying into execution the provisions of the said Union of Benefices Measure, 1923, in regard to the Union of Benefices herein recommended and proposed that an exchange should be made of the Patronage of the said Benefice of Fosbury, Christ Church, for the Patronage of the said Benefice of Froxfield, to the intent that the Patronage of the United Benefice herein recommended and proposed to be constituted shall belong wholly to the said Dean and

Canons of Windsor:

" And whereas the said Dean and Canons of Windsor and the said John Francis William Deacon, Ernest Newton Sharpe, Henry Lawe Corry Vully de Candole, Edward Grose Hodge and Edward Ranulph Kenyon have consented to the recommendations and proposals herein contained:

' Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said St. Clair George Alfred, Bishop of Salisbury (in testimony whereof he has signed this Scheme), and with the consent of the said Dean and Canons of Windsor (in testimony whereof they have caused their Common or Capitular seal to be affixed hereto), and with the consents of the said John Francis William Deacon, Ernest Newton Sharpe, Henry Lawe Corry Vully de Candole, Edward Grose Hodge and Edward Ranulph Kenyon (in testimony

whereof they have respectively signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:-

"1. That the Patronage of the said Benefice of Fosbury, Christ Church, which is now vested in the said John Francis William Deacon, Ernest Newton Sharpe, Henry Lawe Corry Vully de Candole, Edward Grose Hodge and Edward Ranulph Kenyon as aforesaid, shall without any conveyance or assurance in the law other than any Order of Your Majesty in Council affirming this Scheme be transferred from the said John Francis William Deacon, Ernest Newton Sharpe, Henry Lawe Corry Vully de Candole, Edward Grose Hodge and Edward Ranulph Kenyon and shall become and be absolutely vested in the said Dean and Canons of Windsor, and that in exchange for such Patronage so transferred the Patronage of the said Benefice of Froxfield which is now vested in the said Dean and Canons of Windsor shall in like manner and by the same authority be transferred from the said Dean and Canons of Windsor and shall become and be absolutely vested in the said John Francis William Deacon, Ernest Newton Sharpe, Henry Lawe Corry Vully de Candole, Edward Grose Hodge and Edward Ranulph Kenyon.

"2. That the said Benefice of Fosbury, Christ Church, and the said Benefice of Tidcombe shall be permanently united together and form one Benefice with Cure of Souls under the style of 'The United Benefice of Tidcombe with Fosbury' but the Parishes of the said Benefices shall continue distinct in

all respects.
"3. That upon the day when any Order of Your Majesty in Council affirming this Scheme shall be published in the London Gazette the union shall forthwith take effect and the said Reginald Callender if he is then Incumbent of the said Benefice of Fosbury, Christ Church, shall be the first Incumbent of the United Benefice.

'4. That upon the union taking effect the Parsonage House at present belonging to the said Benefice of Fosbury, Christ Church, shall become and be the house of residence for the

Incumbent of the United Benefice.

"5. That upon and from the union taking effect the right of Patronage of and presentation to the United Benefice shall belong wholly to the said Dean and Canons of Windsor.

" Provided always that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England, or of any Act of Parliament.

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1923, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or
