Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the Benefices therein recommended to be united shall be united to the extent and for the purposes recommended in the said Scheme and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Salisbury.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Union of Benefices Measure, 1923, duly prepared, and laid before His Majesty in Council, a Scheme, bearing date the 11th day of November, 1926, in the words and figures following, that is to say:—

“ We, the Ecclesiastical Commissioners for England, acting in pursuance of the Union of Benefices Measure, 1923, have prepared, and now humbly lay before Your Majesty in Council, the following Scheme for effecting the unions (1) of the Benefice of Tremaine (being part of the United Benefice of Egloskerry with Tremaine) with the Benefice of Tresmere and the Benefice of Treneglos (being part of the United Benefice of Treneglos with Warbstow) and (2) of the Benefice of Warbstow (being part of the said United Benefice of Treneglos with Warbstow) with the Benefice of Otterham, all of which Benefices are situate in the County of Cornwall and in the Diocese of Truro :

“ Whereas Commissioners appointed at our request by the Right Reverend Walter, Bishop of Truro, pursuant to the provisions of the said Union of Benefices Measure, 1923, to inquire into and report upon the said unions of Benefices duly made their Report to the said Bishop of Truro and therein recommended such Unions and the terms for effecting the same, and the said Bishop of Truro signified in writing his approval of the said Report :

“ And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for such Unions based upon the terms recommended in the said Report :

“ And whereas the said Benefices of Egloskerry with Tremaine, and Treneglos with Warbstow are now full, the Reverend James Henry Thomas being the present Incumbent of the said Benefice of Egloskerry with Tremaine and the Reverend John Reid Davies being the present Incumbent of the said Benefice of Treneglos with Warbstow and the said Benefices of Tresmere and Otterham are at present vacant :

“ And whereas the said John Reid Davies has consented to become the first Incumbent of the United Benefice of Tresmere with Treneglos and Tremaine, if and when the Unions which are hereinafter recommended and proposed shall take effect :

“ And whereas the Patronage of the said Benefice of Treneglos with Warbstow belongs to and is vested in His Royal Highness Edward Albert Christian George Andrew Patrick David, Prince of Wales, Duke of Cornwall and Rothesay, Earl of Chester and Carrick, Baron of Renfrew, Lord of the Isles and Great Steward of Scotland (hereinafter called ‘ His Royal Highness ’) as parcel of the possessions of the Duchy of Cornwall and the Patronage of the said Benefices of Egloskerry with Tremaine and Tresmere belongs to and is vested in the Bishop for the time being of the said Diocese of Truro :

“ And whereas His Royal Highness and the said Bishop of Truro are consenting to the recommendations and proposals hereinafter made with regard to Patronage :

“ Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consent of the said Walter, Bishop of Truro (in testimony whereof he has signed this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say:—

“ 1. That with the consent of the said James Henry Thomas (testified by his signing this Scheme) a part of the said Benefice of Egloskerry with Tremaine, that is to say, the Benefice of Tremaine, shall be severed from the said Benefice of Egloskerry with Tremaine, and that a part of the said Benefice of Treneglos with Warbstow, that is to say, the Benefice of Treneglos, shall be severed from the said Benefice of Treneglos with Warbstow, and that the said Benefice of Tremaine (severed from the said Benefice of Egloskerry with Tremaine as aforesaid), the said Benefice of Tresmere, and the said Benefice of Treneglos (severed from the said Benefice of Treneglos with Warbstow as aforesaid), shall be permanently united together and form one Benefice with Cure of Souls under the style of ‘ The United Benefice of Tresmere with Treneglos and Tremaine ’ but the Parishes of Tresmere, Treneglos and Tremaine shall continue distinct in all respects.

“ 2. That the said Benefice of Warbstow (after the severance of the said Benefice of Treneglos as aforesaid) and the said Benefice of Otterham shall be permanently united together and form one Benefice with Cure of Souls under the style of ‘ The United Benefice of Warbstow with Otterham ’ and that such United Benefice shall be included in and form part of the Rural Deanery of Trigg Minor but
