

to the point where that road meets the northern boundary of the parish of Dallington, thence in generally south easterly and southerly directions along the eastern boundaries of that parish and the parish of Ashburnham to the point of commencement.

6. (a). An area in the administrative county of Kent comprising so much of the parishes of Smarden, Bethersden, Biddenden, High Holden and Pluckley as lie within the following boundaries namely:—

Commencing at Holden Hill, thence in a north easterly and northerly direction along the road leading via Browns Farm, Rull Green, Bethersden, and Snoadhill to its junction with the road leading from Dowle Street to Chambers Green, thence in a westerly direction along that road via Chambers Green, Rose Farm and Frith Wood to Park Farm, thence in a north westerly direction along the road leading from Park Farm to its junction with the road from Wanden to Swifts Green via Pope House, thence along the last mentioned road to Swifts Green, thence in a south westerly and southerly direction along the road from Swifts Green via Watch House, and Smarden Bell and Hadman's Place to Snughorne, thence in a south easterly direction along the road from Snughorne to its junction with the main Smarden-Biddenden Road at Upland, thence in a south easterly direction along the road leading from Upland to Omenden, thence in south westerly and south easterly directions along the road leading via Dog Kennel to Middle Quarter, thence along the road leading from Middle Quarter to the point of commencement at Holden Hill.

6. (b). An area in the administrative county of Kent comprising:—

The borough of Lydd.

The parish of Midley, and such parts of the parishes of Old Romney and St. Martin's, New Romney as lie to the east and south of the following boundary namely:—

Commencing at Hawthorn Corner at the most northerly point of the parish of Midley, thence in a northerly direction along the road via Wheelsgate, Old Romney Bridge, White's House, Court Lodge and the Rose and Crown Inn to the point where it meets the road from Tenterden to Old Romney; thence in a south easterly direction along the latter road to the point where the road forks and meets the northern boundary of the borough of Lydd at Hammond's Corner, thence following the said boundary of the borough as far as the sea.

SECOND SCHEDULE.

Contracted Infected Area No. 5.

An area in the administrative county of Buckingham comprising the parishes of:—

Dorney (excluding its detached part), Boveney, Eton Wick, Eton Slough and such parts of the parishes of Burnham, Farnham Royal and Stoke Poges as lie to the south of the Road leading from Hitcham to Stoke Green via Goreham and Britwell Road to Farnham Royal; thence in an easterly direction towards Stoke Poges to the cross

roads near Tithe Farm, thence in a south easterly direction passing Clock House and the Pumping Station to the point where that road crosses the Wexham parish boundary.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED 6TH DECEMBER, 1926.)

FOOT-AND-MOUTH DISEASE (DECLARATION OF INFECTED AREAS) ORDER OF 1926 (No. 135).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him, under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

Declaration of Further Foot-and-Mouth Disease Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be a Foot-and-Mouth Disease Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925, and the Foot-and-Mouth Disease (Declaration of Infected Areas) Order of 1926 (No. 116) shall be read and have effect as if the Area described in the Schedule hereto were included as Area No. 11 in the First Schedule to that Order.

Contraction of certain Infected Area.

2. So much of the Area described in the Schedule to this Order as is already comprised within the Foot-and-Mouth Disease Infected Area (No. 8) described in the Schedule to the Foot-and-Mouth Disease (Declaration of Infected Areas) Order of 1926 (No. 129) shall as from the date hereof cease to be included in and to form part of the said Infected Area (No. 8).

Short Title.

3. This Order may be cited as the FOOT-AND-MOUTH DISEASE (DECLARATION OF INFECTED AREAS) ORDER OF 1926 (No. 135) and shall be read with the Orders referred to in Articles 1 and 2.
