Duck Street and West End road, Ebbes-. borne Wake, from the road junction at the School to its junction with the Coombe Bissett —Broad Chalke—Berwick St. John road near West End Farm.

Back Lane, Stapleford, from the Salisbury —Warminster road (A.36) near Pelican Bridge via Over street to its junction with the Salisbury—Devizes road (A.360) near Bury Bridge.

The Back Way from the road junction about 100 yards north of the Railway Station at Wylye via Hanging Langford, Little Langford, Lotmoor and Wishford Railway Station to the rural district boundary south of South Newton.

SECOND SCHEDULE.

Rural District of Chippenham.

Road from the Chippenham—Bath road (A.4) about 650 yards north-east of Lower Pickwick via Hartham Park to the road junction near The Butts, Biddestone.

Rural District of Malmesbury.

Rural District of Wilton.

Horse Shoe Lane from the Salisbury— Shaftesbury road (A.30) near Compton Farm, Compton Chamberlayne, to its junction with the Salisbury—Mere road (B.3089) near Morris Farm south-east of Baverstock.

Commons road from the Salisbury—Warminster road (A.36) near the Church, Steeple Langford, to its junction with the Back Way near Hanging Langford.

ORDER OF THE MINISTER OF AGRICULTURE AND FISHERIES.

(DATED STH DECEMBER, 1926.)

FOOT-AND-MOUTH DISEASE (DECLARA-TION OF INFECTED AREAS) ORDER OF 1926 (No. 137).

The Minister of Agriculture and Fisheries, by virtue and in exercise of the powers vested in him under the Diseases of Animals Acts, 1894 to 1925, and of every other power enabling him in this behalf, hereby orders as follows:—

PART I.

Further Contraction of Norfolk Infected Area.

1.—(1) The Foot - and - Mouth Disease (Declaration of Infected Areas) Order of 1926 (No. 136) shall be read and have effect as if the Area described in the First Schedule to this Order were substituted for the Infected Area (No. 3) described in the First Schedule to that Order.

(2) This Article shall come into operation on the thirteenth day of December, nineteen hundred and twenty-six.

Further Contraction of Ramsbury, Wilts., Infected Arca.

2.—(1) The Foot - and - Mouth Disease Declaration of Infected Areas Order of 1926 (No. 136) shall be read and have effect as if the Area described in the Second Schedule to this Order were substituted for the Infected Area (No. 4) described in the First Schedule to that Order.

(2) This Article shall come into operation on the fifteenth day of December, nineteen hundred and twenty-six.

PART II.

Release of Norfolk Area from Restrictions.

3. The Area described in the First Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions) Order of 1925 as from the twenty-second day of December, nineteen hundred and twenty-six.

Release of Ramsbury, Wilts., Area from Restrictions.

4. The Area described in the Second Schedule to this Order shall cease to be an Infected Area for the purposes of the Foot-and-Mouth Disease (Infected Areas Restrictions). Order of 1925 as from the twenty-fourth day of December, nineteen hundred and twentysix.

Short Title.

5. This Order may be cited as the FOOT-AND-MOUTH DISEASE (DECLARATION OF INFECTED AREAS) ORDER OF 1926 (No. 137).
