

The Home Secretary gives notice that in pursuance of Section 2 (1) of the Employment of Women, Young Persons and Children Act, 1920, he has made an order authorising the employment on two day shifts, of female young persons of 16 years of age and over in cleaning and polishing tinplates by hand at the works of The Melyn Tinplate Company Limited, Melincrythan, Neath, Glam., subject to compliance with the Welfare Order dated 5th October, 1917, and to the conditions that a worker shall not be employed in the afternoon shift in consecutive weeks and that a young person shall not be allowed to lift, carry or move anything so heavy as to be likely to cause her injury.
