

Church, East Coatham, both in the County of York and in the Diocese of York:

"Whereas we are satisfied that the said Parish of Kirkleatham and the said New Parish of Christ Church, East Coatham, are Cures wherein or in parts whereof the provision for public worship and for pastoral superintendence is insufficient for the spiritual wants of the inhabitants thereof and it has been made to appear to us that it would promote the interests of religion that the particular portions of the said Parish of Kirkleatham and of the said New Parish of Christ Church, East Coatham, which are hereinafter mentioned and described, should be constituted a separate District in the manner which is hereinafter set forth:

"And whereas there is not at present within the limits of the said proposed separate District any consecrated Church or Chapel in use for the purposes of Divine Worship:

"And whereas we have agreed to make and pay out of the Common Fund created by the firstly herein mentioned Act a grant of £200 per annum to the Minister of the said proposed separate District so soon as a Minister shall have been duly licensed in accordance with the provisions of the secondly herein mentioned Act and to his successors:

"And whereas the said grant of the said yearly sum of £200 will after the publication in the London Gazette of an Order of Your Majesty in Council ratifying this Scheme be made and secured by an Instrument to be executed by us, the said Ecclesiastical Commissioners, under our Common Seal in accordance with the provisions of the Act of the 29th and 30th years of Her said late Majesty, Chapter 111:

"And whereas there has been contributed and paid to the credit of our account at the Bank of England a capital sum of £2000 towards the cost of erecting a permanent Church within and for the said proposed separate District:

"And whereas the said capital sum of £2000 has been contributed and paid as aforesaid upon the understanding and condition that (such arrangement appearing to us to be expedient) the whole right of Patronage of the said proposed District, and, when such District shall have become a New Parish, then of the said New Parish, and the nomination of the Minister or Incumbent thereof should be assigned in the manner which is hereinafter set forth:

"And whereas the contributors of the said capital sum of £2000 towards the cost of erecting such permanent Church have nominated to us the Archbishop of York for the time being as the person to whom they desire that the whole right of Patronage of the said proposed District or New Parish should be assigned:

"Now, therefore, with the consent of the Right Honourable and Most Reverend Cosmo Gordon, now Archbishop of York (in testimony whereof he has signed and sealed this Scheme), we, the said Ecclesiastical Commissioners, humbly recommend and propose that all those portions of the said Parish of Kirkleatham and of the said New Parish of Christ Church, East Coatham, which are described in the Schedule hereunder written, all which portions together with the boundaries thereof are delineated and

set forth on the map or plan hereunto annexed, shall, upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this Scheme as aforesaid, become and be constituted a separate District for spiritual purposes, and that the same shall be named 'The District of Dormanstown.'

"And we further recommend and propose that the whole right of Patronage of the said District so recommended to be constituted and, when such District shall have become a New Parish as aforesaid, then of the said New Parish, and the nomination of the Minister or Incumbent thereof shall without any assurance in the law other than this Scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in the said Cosmo Gordon, Archbishop of York, and his successors, Archbishops of York, for ever.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Acts, or of any of them, or of any other Act of Parliament.

"THE SCHEDULE to which the foregoing Scheme has reference.

"The District of Dormanstown comprising:—

"1. All that portion of the Parish of Kirkleatham, in the County of York and in the Diocese of York, which is bounded upon the south by the Parish of Wilton, in the said County and Diocese, upon the south west partly by the last named Parish and partly by the New Parish of Saint Matthew, Grange-town, in the said County and Diocese, upon the west by the middle of the River Tees, upon the north east by the New Parish (sometime Particular District) of Christ Church, East Coatham, in the said County and Diocese, and upon the remaining sides, that is to say, upon the east and upon the south east, by an imaginary line commencing upon the boundary which divides the said New Parish of Christ Church, East Coatham, from the said Parish of Kirkleatham at the centre of Coatham Bridge which carries Kirkleatham Lane across the stream known as The Fleet, and extending thence southward along the middle of Kirkleatham Lane for a distance of 51 chains or thereabouts to a point opposite to the eastern end of the fence forming the southern boundary of the close numbered 282 upon the Ordnance Survey Map of the Civil Parish of Kirkleatham published in the year 1915 upon the scale of 25 inches to a mile and also upon the map or plan which is annexed to this Scheme, and extending thence first south westward to and along the said fence and along the fences forming the southern boundaries of the closes numbered 273, 272, 271 and 251 upon the said maps and then first south eastward and then again south westward along the fences forming the eastern and southern boundaries of the close numbered 254 upon the same maps for a distance in all of 68 chains or thereabouts to the point where the fence forming the southern boundary of the said close num-
