ASSIGNMENT OF DUTIES AND DISTRICT.

The Minister of Health, by an Order dated 28th January, 1927, made under the District Auditors Act, 1879, has assigned to William Erskine Pitcairn, District Auditor, the North Western Area, No. 4, Audit District, as the District in and for which the said District Auditor shall act.

ILFORD.

Whereas the Mayor, Aldermen, and Burgesses of the Borough of Ilford (hereinafter called the Corporation), being the Urban Sanitary Authority for the said Borough, have made application to the Minister of Health for the issue of a Provisional Order under Sections 297 and 303 of the Public Health Act, 1875, partially to repeal, alter or amend the Ilford Urban District Council Act, 1904, so as:—

(1) To provide that all accounts of the Corporation and of the Borough Treasurer and the Officers of the Corporation shall be audited by a District Auditor appointed by the Ministry of Health in like manner as accounts of an Urban Authority and their Officers are audited under Sections 247 and 250 of the Public Health Act, 1875, in lieu of the audit required by the Municipal Corporations Act, 1882.

(2) To provide that the Corporation may out of the Borough fund defray reasonable expenditure incurred by them upon any of the following purposes:—

(a) Annual or other subscriptions to the funds of any association of municipal Corporations or other local authorities or their officers formed for the purpose of consultation as to their common interests and the discussion of matters relating to local government:

(b) In the attendance of members or officers of the Corporation at conferences or meetings of any such association and in

the purchase of reports of the proceedings of such conferences or meetings:

(c) In connection with the presentation of the Freedom of the Borough to persons whom the Corporation may resolve to admit as honorary Freeman: or

(d) In connection with occasions of public ceremony or festival, or in the reception or entertainment of distinguished persons.

(3) For the several purposes of the Application or for the purposes connected with, incidental to, or consequent on those purposes to make any such alteration or amendment of the said Local Act, or of any other Local Act or of any Act confirming a Provisional Order made in pursuance of any of the Sanitary Acts or of the Public Health Act, 1875, and in force in the said Borough as may be necessary or desirable:

And whereas it is proposed that a Provisional Order should be issued in compliance with the said Application:

MINISTRY OF TRANSPORT.

IN THE MATTER OF THE LONDON TRAFFIC ACT, 1924.

Notice is hereby given under the Rules Publication Act, 1893, that it is proposed by the Minister of Transport after the expiration of at least forty days from this date in pursuance of the powers conferred upon him by Section 7 of the aforesaid London Traffic Act to make regulations amending the London Traffic (Restricted Streets) (No. 2) Regulations, 1925 (S.R. & O. 1925, No. 806); with respect to streets which by the London Traffic (Restricted Streets) (No. 2) Order (S.R. & O. 1925, No. 549) have been declared by the Minister of Transport to be "restricted streets."

And notice is hereby further given that on account of urgency the Minister of Transport has under Section 2 of the Rules Publication Act, 1893, made the London Traffic (Restricted Streets) Amendment (Harrow) Provisional Regulation, 1927, to come into operation forthwith as provisional regulations to continue in force until regulations have been made in
