THE FAIRS ACT, 1873.

ABERGAVENNY FAIRS.

Whereas on the 25th March, 1926, a representation was made to the Secretary of State for the Home Department by the Town Council of the Borough of Abergavenny, to the effect that Fairs have been held annually in the Borough of Abergavenny, in the county of Monmouth, on the 14th day of May and the 25th day of September, and that it would be for the convenience and advantage of the public that such Fairs should in future be held on the second Tuesday in the month of May and the third Tuesday in the month of September in each year.

And whereas notice of the said representation and of the time when the same would be taken into consideration has been duly published in pursuance of "The Fairs Act, 1873":

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fairs should in future be held on the second Tuesday in the month of May and the third Tuesday in the month of September in each year:

Now therefore I, as Secretary of State for the Home Department, in exercise of the powers vested in me by "The Fairs Act, 1873," do hereby order that the Fairs which have been held annually in the Borough of Abergavenny, in the county of Monmouth, on the 14th day of May and the 25th day of September, shall in future be held on the second Tuesday in the month of May and the third Tuesday in the month of September in
