ORDER OF THE REGISTRAR GENERAL
IN ENGLAND.

(Dated 8th March, 1927.)

Whereas under Section 21 of the Births and Deaths Registration Act, 1874, the Registrar General, with the sanction of the Minister of Health, may from time to time alter Registration Sub-Districts:—

And whereas by the Upper Mitton Order, 1927, it is provided that, on the 1st April, 1927, the Parish of Upper Mitton shall be separated from the Droitwich Union and shall be added to and form part of the Kidderminster Union.

And whereas it is expedient that a corresponding alteration should be made in the constitution of the Registration Sub-districts hereinafter mentioned:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Droitwich and Kidderminster Registration of Births, &c. (Alteration of Sub-districts), Order, 1927, and shall come into operation on the 1st day of April, 1927.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The Civil Parish of Upper Mitton, which on the 1st April, 1927, will be transferred by the recited Order to the Kidderminster Union, shall cease to form part of the Ombersley Sub-district of Droitwich Registration District and shall be added to and form part of the Lower Mitton Sub-district of Kidderminster Registration District.

4. The existing Lower Mitton Sub-district as extended by this Order shall be renamed the Stourport Sub-district.
