

Health, may from time to time alter Registration Sub-Districts:—

And whereas by the Wolverhampton Corporation Act, 1926, it is enacted, *inter alia*, that, on the 1st April, 1927, the boundaries of the Borough of Wolverhampton shall be extended to include parts of the Parishes of Bushbury, Wrottesley, and Upper Penn.

And whereas it is expedient that certain corresponding alterations should be made in the constitution of the Registration Sub-districts hereinafter mentioned:—

Now, therefore, I, Sylvanus Percival Vivian, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers conferred by the Births and Deaths Registration Acts, 1836 to 1901, and with the sanction of the Minister of Health, do hereby order as follows:—

1. This Order may be cited as the Wolverhampton and Cannock Registration of Births, &c. (Alteration of Sub-districts) Order, 1927, and shall come into operation on the 1st April, 1927.

2. The Interpretation Act, 1889, applies to the interpretation of this Order as it applies to the interpretation of an Act of Parliament.

3. The part of the Civil Parish of Bushbury which, on the 1st April, 1927, will be transferred by the recited Act to Wolverhampton Union and Civil Parish, shall cease to form part of the Brewwood Sub-district of Cannock Registration District, and shall be added to and form part of the Willenhall Sub-district of Wolverhampton Registration District.

4. The part of the Civil Parish of Wrottesley which, on the 1st April, 1927, will be transferred by the recited Act to Wolverhampton Union and Civil Parish, shall cease to form part of the Tettenhall Sub-district of Wolverhampton Registration District and shall be added to and form part of the Willenhall Sub-district of the same Registration District.

5. The part of the Civil Parish of Upper Penn which, on the 1st April, 1927, will be transferred by the recited Act to Wolverhampton Union and Civil Parish, shall cease to form part of the Wombourn Sub-district of Wolverhampton Registration District and shall be added to and form part of the Wolverhampton Western Sub-district of the same Registration District.

6. The Superintendent Registrar of the existing Wolverhampton Registration District shall be the Superintendent Registrar of that Registration District as extended by this Order.

7. The Registrars of the existing Sub-districts of Willenhall and Wolverhampton Western shall be respectively the Registrars of those Sub-districts as extended by this Order.

BOURTON - ON - THE - WATER ELECTRICITY.

NOTICE is hereby given that the Bourton-on-the-Water Electric Light and Power Company Limited (hereinafter called "the Company") whose registered office is at the Electricity Works Sherborne Street Bourton-on-the-Water in the County of Gloucester are applying to the Electricity Commissioners under the provisions of the Electricity (Supply) Acts 1882 to 1926 for a Special Order for the following amongst other purposes (that is to say):—

1. (a) To authorise the Company to generate and distribute electricity for public and private purposes as defined by the said Acts within the Parish of Bourton-on-the-Water in the Rural District of Stow-on-the-Wold in the County of Gloucester (hereinafter called "the area of supply").

(b) To authorise the Company to exercise in the area of supply the powers usually conferred on distributors of electrical energy and to prescribe the maximum prices to be charged under the Order.
