

said County and Diocese, which is bounded upon the south east by the said New Parish of Hollinwood and upon the remaining sides, that is to say, upon the south west, upon the north west and upon the north east, by an imaginary line commencing at the point where the boundary which divides the said New Parish of Hollinwood from the said New Parish of Christ Church, Chadderton, crosses the middle of Wharf Street, and extending thence north westward along the middle of Wharf Street for a distance of $1\frac{1}{2}$ chains or thereabouts to its junction with Carrington Street, and extending thence north eastward along the middle of Carrington Street for a distance of $4\frac{1}{2}$ chains or thereabouts to its junction with the passage leading along the backs of the houses and premises situate on the north eastern side of Hardman Street, and extending thence south eastward along the middle of such passage for a distance of 2 chains or thereabouts to a point at or near its junction with the passage leading along the backs of the houses and premises situate on the north western side of Manchester Road upon the boundary which divides the said New Parish of Christ Church, Chadderton, from the said New Parish of Hollinwood.

“ THE SECOND SCHEDULE.

“ The territory to be dissevered from the said New Parish of Hollinwood, and to be annexed to the New Parish of Emmanuel, Chadderton, in the said County and Diocese, being:—

“ I. All that portion of the said New Parish of Hollinwood which is bounded upon the south west by the New Parish of Failsworth, in the said County and Diocese, upon the north west and upon the north east by the said New Parish of Emmanuel, Chadderton, and upon the remaining side, that is to say, upon the south east, by an imaginary line commencing at the point near the junction of Sefton Street and Manchester Road where the boundary which divides the said New Parish of Emmanuel, Chadderton, from the said New Parish of Hollinwood crosses the middle of Manchester Road, and extending thence south westward along the middle of Manchester Road for a distance of $13\frac{1}{2}$ chains or thereabouts to its junction with Hollins Road and Oldham Road, and extending thence south westward along the middle of Oldham Road for a distance of $7\frac{1}{2}$ chains or thereabouts to the boundary which divides the said New Parish of Hollinwood from the said New Parish of Failsworth.

“ II. And also all that portion of the said New Parish of Hollinwood which is bounded upon the south, upon the west and upon the north by the said New Parish of Emmanuel, Chadderton, and upon the remaining sides, that is to say, upon the east and upon the south east, by an imaginary line commencing at the point in the middle of Canal Street where the boundaries of the said New Parish of Emmanuel, Chadderton, the said New Parish of Hollinwood and the said New Parish of Christ Church, Chadderton, all meet, and extending thence southward along the middle of Canal Street, for a distance of $4\frac{1}{2}$ chains or thereabouts to its junction with Manchester Road, and extending thence south westward along the middle of Manchester Road for a

distance of 15 chains or thereabouts to the point near its junction with Bourne Street, where the boundary which divides the said New Parish of Hollinwood from the said New Parish of Emmanuel, Chadderton, crosses the middle of Manchester Road.

“ THE THIRD SCHEDULE.

“ The territory to be dissevered from the said New Parish of Hollinwood and to be annexed to the said New Parish of Christ Church, Chadderton, being:—

“ I. All that portion of the said New Parish of Hollinwood which is bounded upon the north west by the said New Parish of Christ Church, Chadderton, and upon the remaining sides, that is to say, upon the west, upon the south east and upon the north east, by an imaginary line commencing at the point in the middle of Canal Street where the boundaries of the said New Parish of Christ Church, Chadderton, the said New Parish of Emmanuel, Chadderton, and the said New Parish of Hollinwood all meet, and extending thence southward along the middle of Canal Street for a distance of $4\frac{1}{2}$ chains or thereabouts to its junction with Manchester Road, and extending thence north eastward along the middle of Manchester Road for a distance of 9 chains or thereabouts to its junction with Wharf Street, and extending thence north westward along the middle of Wharf Street for a distance of $2\frac{1}{2}$ chains or thereabouts to the boundary which divides the said New Parish of Hollinwood from the said New Parish of Christ Church, Chadderton.

“ II. And also all that further portion of the said New Parish of Hollinwood which is bounded upon the west by the said New Parish of Christ Church, Chadderton, upon the north east by the New Parish of Saint John, Chadderton, in the said County and Diocese, and upon the remaining sides, that is to say, upon the east and upon the south, by an imaginary line commencing upon the boundary which divides the said New Parish of Saint John, Chadderton, from the said New Parish of Hollinwood, at the junction of Old Lane with Manchester Road, and extending thence south westward along the middle of Manchester Road for a distance of $9\frac{1}{2}$ chains or thereabouts to its junction with Wilton Street, and extending thence north westward along the middle of Wilton Street for a distance of $1\frac{1}{2}$ chains or thereabouts to its junction with the passage leading along the backs of the houses and premises situate on the north western side of Manchester Road, and extending thence south westward along the middle of such passage for a distance of $1\frac{1}{2}$ chains or thereabouts to a point at or near its junction with the passage leading along the backs of the houses and premises situate on the north eastern side of Hardman Street upon the boundary which divides the said New Parish of Hollinwood from the said New Parish of Christ Church, Chadderton.”
