MERCHANDISE MARKS ACT, 1926.

In accordance with the provisions of Sub-section 4 of Section 2 of the Merchandise Marks Act, 1926, the Board of Trade give notice that, in pursuance of applications received by them for the making of Orders in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by them under the Act in respect of the following classes and descriptions of goods:—

(1) (a) The following descriptions of steel:—

Plates, rails, joists, angles, channels, sectional material of all descriptions, castings, forgings, rounds, squares, flats, hexagons, hoops, hot and cold rolled strip.

(b) The following descriptions of wrought iron:—

Bars, hoops, sections, plates and sheets.

(2) Silk and cotton woven labels used by clothing manufacturers, merchants, and retailers.

(3) Gold and silver leaf.
