These charges are in all cases for a telephonic communication of not more than 3 minutes' duration. The charge for each additional minute, or fraction of a minute after the first 3 minutes, is one third of the above mentioned charges, calculated to the nearest penny.

The hours during which the day charges apply are those between 8 a.m. and 7 p.m. (legal time of the country in which the call originates). The hours during which the night charges apply are those between 7 p.m. and 8 a.m. (legal time of the country in which the call originates).

NOTE.—In the case of a call to or from a call office the usual call office fees will be payable in addition to the other charges.
