borough, and therein recommended the transfer to the said Parish of Congerstone of parts of the said Parishes of Market Bosworth, Norton by Twycross, and Shackerstone, and further recommended the transfer to the said Parish of Congerstone of parts of the said Parishes of Nailstone and Carlton and the said Bishop of Peterborough signified in writing his approval of the said Report:

his approval of the said Report:

"And whereas we, the said Ecclesiastical Commissioners for England, have prepared this Scheme for the alteration of the boundaries of the said Parishes, which Scheme is based upon the terms recommended in the

said Report:

"And whereas under the provisions of the said Union of Benefices Measure, 1923, the consents of the Patrons of the said Benefices of Nailstone and Carlton are requisite to the recommendations and proposals herein contained, the said Benefices of Nailstone and Carlton not being referred to in the Commission appointed by the said Bishop as aforesaid:

" And whereas all of the said Benefices of Congerstone, Market Bosworth, Norton by Twycross, Nailstone, Shackerstone, and Carlton, are now full, the Reverend Adrian Stewart Rolleston being the present Incumbent of the said Benefice of Congerstone, the Reverend Edward Law Harkness being the present Incumbent of the said Benefice of Market Bosworth, the Reverend John Carpenter being the present Incumbent of the said Benefice of Norton by Twycross, the Reverend Spencer Bardsley Baron being the present Incumbent of the said Benefice of Nailstone, the Reverend William Smith Price being the present Incumbent of the said Benefice of Shackerstone, and the Reverend Edward Palin Herbert being the present Incumbent of the said Benefice of Carlton:

" Now, therefore, we, the said Ecclesiastical Commissioners for England, with the consents of the said Cyril, formerly Bishop of Peterborough and now Bishop of Leicester, of the Right Honourable Stanley Baldwin, Majesty's First Lord of the Treasury, on behalf of Your Majesty as Patron of the said Benefice of Nailstone, of George Frederick Renner, of Number 34 South John Street, in the City of Liverpool, Esquire, as the Patron of the said Benefice of Carlton, and of the said Adrian Stewart Rolleston, the said Edward Law Harkness, the said John Carpenter, the said Spencer Bardsley Baron, the said William Smith Price, and the said Edward Palin (testified by Herbert their signing this Scheme), do humbly recommend and propose to Your Majesty as follows, that is to say :-

"1. That upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme (a) all those parts of the said Parishes of Market Bosworth and Norton by Twycross which are situate within the limits of the Civil Parish of Bilstone, and (b) all those parts of the said Parishes of Market Bosworth, Nailstone, Shackerstone, and Carlton which are situate within the limits of the Civil Parish of Congerstone, shall be severed from the Parishes of which they now form part and shall thereupon and thenceforth be transferred and annexed for all ecclesiastical purposes to the said Parish of Congerstone,

but save as hereinafter provided no portion of the endowment or property of any of the said Benefices shall be transferred or dis-annexed by reason of such alterations of boundaries.

2. That upon the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council affirming this Scheme (as aforesaid) or upon the day of the date of the vacation of the said Benefice of Market Bosworth by the said Edward Law Harkness, whichever date shall be the later, a portion of the endowment or property now belonging to the said Benefice of Market Bosworth that is to say all those Tithe Commutation rentcharges amounting to £20 9s. 0d. arising within the limits of the Township of Bilstone and now or formerly payable to the Incumbent for the time being of the said Benefice of Market Bosworth together with all capital sums of money, stocks, or other property being or representing the proceeds of the sale, redemption or other conversion of any part or parts of such Tithe rentcharge shall be transferred and annexed to the said Benefice of Congerstone.

"Provided always that nothing herein contained shall prevent us from recommending and proposing any other Measures relating to the matters aforesaid, or any of them, in accordance with the provisions of the said Measure, or of any other Measure of the National Assembly of the Church of England,

or of any Act of Parliament."

And whereas drafts of the said Scheme have been duly published in accordance with the provisions of the said Union of Benefices Measure, 1928, and Notices have been transmitted to the persons or bodies entitled under the same Measure to receive Notice requiring any objections to such draft Scheme to be stated or transmitted in writing to the said Ecclesiastical Commissioners within the time prescribed in the Statutory Rules applicable to proceedings under the said Union of Benefices Measure, 1923:

And whereas the prescribed time has elapsed and no such objections have been so stated or transmitted to the said Ecclesiastical Commissioners:

And whereas public notice of the certification to His Majesty in Council of the said Scheme and the consent thereto in writing of the Bishop of Leicester has been duly given in the manner and within the time prescribed in the Statutory Rules aforesaid:

And whereas the said Scheme has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to affirm the said Scheme and to order that the alterations of boundaries therein recommended shall be effected to the extent and for the purposes recommended in the said Scheme, and further to order and direct that the said Scheme and every part thereof shall be effectual in law immediately from and after the date when this Order shall have been duly published in the London Gazette pursuant to the said Measure.

And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Leicester.
