#### UNIVERSITY OF LONDON.

Notice is hereby given, in pursuance of the University of London Act, 1898, that the following new Statute (No. 28 (a)) for the Management of the University of London, University College, has been made by the Senate of the University of London, and that copies of the new Statute can be obtained on application to "The Secretary to the Senate, University of London, South Kensington, S.W. 7."

The Senate have this day adopted a Resolution making a new Statute (No. 28 (a)) for the Management of University of London, University College, as follows:—

28 (a) The Senate may on the advice of the College Committee grant the title of Honorary Fellow of University College, London, to persons of distinction who have rendered exceptional services to the College or to the cause of education generally, or have attained distinction in Art, Science, Literature or public life.
